HOME OCCUPATION AFFIDAVIT

The following is the definition of Home Occupation taken from the City Zoning Ordinance:

Home Occupation: A domestic activity carried on by no more than two members of a family residing on the premises, but excluding beauty shops, barber shops, music schools, convalescent or nursing homes, tourist homes, massage or other establishment offering services to the general public, and providing that there are no signs nor any display that will indicate from the exterior of the building that it is being utilized, in the whole or part, for any commodity sold upon the premises, no person is employed other than a member of the family residing on the premises, and no mechanical equipment is used except such as is customary for purely domestic or household purposes. The keeping of not more than two roomers or boarders shall be considered a permitted home occupation.
