Pastor Boyd Brooks from People's Church offered the opening prayer.

## **ACCEPTANCE OF THE MINUTES:**

Bill Moritz moved to accept the minutes of the March 24, 2011 meeting if there were no deletions, errors or corrections. Ken Moss seconded the motion. Roll call vote: Edwards, yes; Crisler, yes; Moritz, yes; Freese, yes; Lang, yes; Moss, yes; Lindsley, yes; Connell, yes; 8 yeas, Motion carried.

#### **ACCEPTANCE OF THE WARRANTS:**

City Clerk Diane Waller read **Payroll warrant #1104**. Paul Freese moved **to pay payroll warrant #1104** in the amount of \$240,013.98 if the monies are available. Seconded by Jim Edwards. City Clerk Diane Waller read **general warrant** #5544. **Bob Lindsley moved to pay general warrant** #5544 in the amount of \$573,873.93 if the monies are available. Seconded by Paul Freese. Roll call vote: Edwards, yes; Crisler, yes; Moritz, yes; Freese, yes; Lang, yes; Moss; yes; Lindsley, yes; Connell, yes; 8 yeas, **Motion carried.** 

### **BUSINESS FROM THE FLOOR**

The Mayor explained how anyone could speak for up to 3 minutes on any matter of city business, but first must identify himself or herself and state their address. He also reiterated the necessity of using the speaker cards.

**Dennis Mraz**, 1375 Big Bill, and also a member of Clean Stream, shared photos of recent clean-up activities. He feels there are squatters and they are leaving debris and trash that he is removing. Also reported, he has observed people using city dumpsters in the parks and that signage is no longer present advising this is against the law. He also expressed his disappointment that he had not been able to reach Mr. Unrein to discuss this. Also suggested city repair gates and update park diagrams on our brochure.

Ms. Tina Hill, 1676 Trinity, expressed she is very concerned about the activities reported at the Value Place Hotel. She questioned why she is first hearing of it now. Mr. Unrein addressed her concerns by advising he will talk about this later in the meeting.

**Mr. Dennis Murphy**, Jefferson County Community Partnership, provided stats on ridership on the new bus and presented Certificate of Appreciation to the city for their contributions to Hammers of Hope. He also thanked everyone who had participated and provided individual certificates to Diane for distribution.

## RESOLUTIONS

RESOLUTION 11-09 A RESOLUTION AUTHORIZING THE CITY TO VACATE CERTAIN RIGHT-OF-WAY ALONG MISSOURI STATE AND LEMAY FERRY ROADS was offered by Bill Moritz and he so moved. Seconded by Jim Edwards. Roll call vote: Edwards, yes; Crisler, yes; Moritz, yes; Freese, yes; Lang, yes; Moss, yes; Lindsley, yes; Connell, yes; 8 yeas, motion carried.

## **NEW BUSINESS**

Ken Moss reported earlier this week he had asked Mr.Unrein to have an executive session on the agenda and it is not. He is still waiting for an answer and Mr. Edwards asked yesterday for an addition to the agenda. Mr. Moss was questioning and asking for verification as to what are the correct procedures to get something on the agenda.

Mr. Unrein responded this was a misunderstanding. He didn't feel this matter had to be handled right away and thought it could have happened at a later meeting. Regarding the comment about Mr. Edwards, he explained he was waiting to hear from the attorney and once he had, he would contact Mr. Edwards. Once he heard from attorney,the next day, attorney advised he would contact Mr. Edwards.

Mr. Unrein explained the procedure, that it is set by ordinance, and the formal process to follow. Again, stating he misunderstood and thought Mr. Moss's issue could be for a future date.

Attorney Sweeney added he did talk with Mr. Edwards, rather than Mr. Unrein speaking with Mr. Edwards on this issue. It appears there was miscommunication.

Bob Lindsley brought up location of political signs and violations. Mayor added the city does not normally act on this unless there is a safety issue and/or complaints. Mr. Lindsley would like to see city provide our sign ordinance to all candidates when they file in Hillsboro. Ms. Waller advised we do provide our ordinance to the county and they provide this to candidates. Mr. Crisler confirmed when he filed in the county, he was provided this information.

Bill Moritz suggested amending the agenda to bring Mr. Unrein's Administrative Report to this part of the meeting so the Value Place Hotel issues could be addressed. No motion will be needed and Matt reported city officials have been in touch with officials from Value Place Hotel. Value Place has agreed to have a uniformed off duty police officer (at their expense) there 24 hours a day, 7 days a week. They are also performing criminal record checks. This should deter criminal activity.

Chief Shockey added Value Place is cooperating and wants these problems fixed.

Mayor emphatically reiterated, the city will not tolerate any more of these activities and city has made this clear to Value Place. City is on top of this situation.

Mr. Edwards addressed the lady in the audience that felt she was not informed and added as a councilman, he only recently learned of this.

Attorney Sweeney responded, "criminals have rights" and explained the legalities and our police department is doing their job. He did understand and have empathy for Ms. Hill and her concerns.

Ms. Hill expressed she feels her safety is in jeopardy.

Chief explained, the Arnold Police Department is protecting residents and has protected them by making these arrests and demanding cooperation from the Hotel.

Connell questioned if the city is locked in to the date of the  $15^{th}$  or if we can still take action and pull the license.

Attorney assured everyone we still can, and will, take action if needed.

Ken Moss thanked the Parks Department for the Facebook pop-ups and questioned Matt where the new photos are. Mr. Unrein responded he is working on that.

Paul Freese asked about the status on the Red Light Camera RFQ and Chief responded this was advertised and the deadline to respond is April 29<sup>th</sup> at 3 PM.

Jim Edwards asked Matt Unrein about following up with Bob to make sure city collects fees and fines that are due.

Bob Lindsley reported on the recent Tourism meeting regarding budget issues and the proposed Farmer's Market.

Paul Freese announced the next Fall Festival meeting would be June 6 at the Rec Center.

Dan Kroupa shared that he and Dan Bish would attend the Jefferson County Economic Development meeting early next Wednesday morning.

Bill Moritz reported there had been a Liquor Control Committee meeting this evening. He offered a motion to recommend approval of a picnic liquor license for Immaculate Conception Church for their picnic May 20 and 21 and so moved. Seconded by Jim Edwards. Roll call vote: Edwards, yes; Crisler, yes; Moritz, yes; Freese, yes; Lang, yes; Moss, yes; Lindsley, yes; Connell, yes; 8 yeas, motion carried.

He also reported there had been a request submitted from Las Fuentes to apply to the state for an extension of premise license for their Cinco De Mayo celebration May 5, May 6 and May 7<sup>th</sup>. He offered a motion to approve, provided they fulfill all other city requirements, and so moved. Seconded by Jim Edwards.
