Mayor Ron Counts called the meeting to order at 7:26 pm.

The Pledge of Allegiance was recited.

Rev. Tim Gray of the Bridge Community Church said the opening prayer.

Councilman Freese left council chambers at 7:27 pm.

ACCEPTANCE OF MINUTES:

Bill Moritz moved to accept the minutes of the March 15, 2012 meeting if there were no deletions, errors or corrections. Jeff Fitter seconded the motion. Roll call vote: Moss, yes; Borgelt, yes; Lang, yes; Fitter, yes; Moritz, yes; Amato (out of room); Freese (out of room); Kownacki, yes; 6 yeas: Motion carried.

ACCEPTANCE OF WARRANTS:

City Clerk Diane Waller read Payroll Warrant #1130. **Doris Borgelt made a motion and moved to pay Payroll Warrant #1130 in the amount of \$241,758.38** if the monies are available. Seconded by Cricky Lang. Roll call vote: Moss, yes; Borgelt, yes; Lang, yes; Fitter, yes; Moritz, yes; Amato (out of room); Freese (out of room); Kownacki, yes; 6 yeas, **Motion carried.**

City Clerk Diane Waller read General Warrant #5568. **Jeff Fitter made a motion and moved to pay General Warrant #5568 in the amount of \$681,287.60** if the monies are available. Seconded by Bill Moritz. Roll call vote: Moss, yes; Borgelt, yes; Lang, yes; Fitter, yes; Moritz, yes; Amato (out of room); Freese (out of room); Kownacki, yes; 6 yeas: **Motion carried.**

BUSINESS FROM THE FLOOR

Mayor explained the procedure to speak and the need to provide speaker cards.

Mike Evans, 509 Hannah Way, congratulated his opponent Paul Freese but he was not in the chamber. He reminded all those serving to never forget the people you represent and added he and Paul were going to now work together for the people.

2 Regular Meeting April 5, 2012

Michelle Tyler, 1964 Glatt, expressed concerns for the problems with speeders on the street and wants the city to do something. She provided a handout, which is attached. She indicated she had sent letters and made contacts with city personnel but no one has contacted her.

Councilman Moss addressed her alleged remarks about not responding; stating he never received the letter she referred to. He then explained how speed humps could possibly be used if all else fails and this could be discussed.

Mr. Unrein explained the process to follow when issues like this come up: increased police presence, additional signage; adding speed humps is not the first step. He will be in touch with her if she provides contact information.

Mayor assured Ms. Tyler, we all want safe streets and city will start the process to see if something can be done to make the street safer.

Ms. Kownacki acknowledged she has had conversations with Ms. Tyler and the Chief.

The Chief also reported the police have been on Glatt.

Jeff Fitter acknowledged Ms. Tyler's remark about a child that was hit and suggested, in the future, a police officer should be called.

Paul Tyler, 1964 Glatt, expressed his opinion that this situation is going to escalate, sharing other incidences on the street and asked for additional signage. He has taken the issue in his own hands and has confronted the speeders.

Mayor again stated our police officers are doing a great job, but we will initiate something to help with this situation.

Paul Freese and Phil Amato both returned to the Council Chamber at 7:42 pm.

Christopher Cepicky, 2105 Blossom, identified himself as the owner of New Coat Sealing and felt his company should be awarded the crack seal work for the Arnold streets. He had done the rec center parking lot and soon would be doing the city hall parking lot. He felt he is more familiar with the roads but was the second lowest bidder.

Lloyd Rodgers, 861 Morningside, spoke about a clean campaign for City Council and how most citizens expect this. If done otherwise, it's an insult. He thanked those that were decent.

Clarence Thurman, 6227 Meadowgreen Estates, (no speaker card) reported his daughter and her family lives in Tamarack and all are concerned about response time with a gate.

Treasurer Kroupa left the chambers at 7:45 pm.

Mr. Moritz explained the Rock Fire Department is in very close proximity and the gate itself will be sound activated so the gate will open when emergency personnel activate a siren. This is the last resort as drivers drove around the speed humps, ignored additional signage and actually drove into yards where children were playing. It is about safety.

Mr. Thurman continued to debate Mr. Moritz's remarks and continued to disagree until the Mayor informed him his time was up.

Kristopher Appel, 3005 Brentmoor Dr. in Tamarack, (no speaker card) felt the residents who used to cut through in Theodore Ridge must now use Vogel and Miller intersection and accidents will go up there.

Jeff Lang, 3074 Brentmoor, (no speaker card) felt city should be neighborly and offered other suggestions rather than the closing of the street. He indicated he was in the printing business and could have printed flyers directing the drivers to slow down.

He went on to insinuate this was a class issue and the Mayor interrupted him advising him to not go there, reiterating this is about safety and not class. Mayor advised him he was done and directed him to sit down. When Mr. Lang continued Mayor instructed police officer to remove him from the room. Mr. Lang was escorted out of the Council Chambers by the Police Officer.

Chief Shockey left the chambers at 7:53 pm.

William Moore 2789 Pinebrook in Tamarack (no speaker card) identified with the speeding problem as he has lived there 34 years and understands the speeding issues. However, he felt that a flyer asking Tamarack residents to follow the speed limit could have worked.

Sandra Myers, **2769** Megan Ct. in the Brentmoor subdivision, also said this is a safety issue and agrees with a previous comment concerning response time. She felt residents could have been notified to help out with a solution and felt they were owed this opportunity.

Dwyane Smith, 3139 Theodore, thanked the council for taking the actions necessary to make the street safer. When he purchased the property, it was in the contract that the street would be closed. As residents, they have tried signage, speed humps and those efforts are not working. This is a safety issue.

Treasurer Dan Kroupa and Police Chief Shockey returned to the chamber at 8 pm

Andrea Swenson, identified herself as a resident of Tamarack, living on Pinebrook, and said this action has pushed the traffic into her subdivision and their police protection is not as good as Arnold. She added they have their own issues.

Ken Moss stated that Dierbergs management had received a comment about possibly losing business since the barricade went up as residents felt it took longer to get to their store. Mr. Moss indicated he actually drove both routes and going through Theodore, added seconds to the trip.

Jeff Fitter explained how the city has dealt with this situation for quite some time now and was assured by the Rock Fire Department that response time will not change.

Ms. Patty Raney, 2765 Tamarack, a 19 year resident of the Tamarack subdivision questioned how those residents can get police protection and asked what do they need to do in their subdivision as they were denied speed humps by Jefferson County.

Paul Freese advised they need to speak to the County. He reiterated, Arnold City Police cannot help them; they have to go to Hillsboro.

Jeff Fitter offered they should contact their County Council Representative, Bob Boyer.

Cricky Lang added speed limits need to be followed.

Mayor stated the agenda needed to be amended to move Resolution No. 12-24 to this part of the meeting. **A motion was made to amend agenda to move Resolution No. 12-24** to this part of the meeting by Jeff Fitter and he so moved. Seconded by Paul Freese. Roll call vote: Moss, yes; Borgelt, yes; Lang, yes; Fitter, yes; Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; 8 yeas, motion carried.

RESOLUTION NO. 12-24 A RESOLUTION DECLARING THE NECESSITY OF ESTABLISHING A SANITARY SEWER SUBDIVISION TO BE KNOWN AS BLACK OAK TRAIL SEWER SUB-DISTRICT.

Bryson Baker explained the sequence to follow when setting up a sewer sub district and provided the background on the Black Oak issue. Residents now have failing septic systems and need to either replace or hook up to our sewer system. They have approached the city for assistance.

RESOLUTION NO. 12-23 A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH PARKING LOT MAINTENANCE, LLC FOR THE CITY OF ARNOLD CRACK SEAL PROGRAM was discussed.

Public Works Director explained how city went out for bid; lowest bid was Parking Lot Maintenance. He reviewed their work and got excellent recommendations from other municipalities.

Doris Borgelt offered a motion to amend Res No. 12-23 and award to New Coat. Seconded by Paul Freese. Much discussion followed.

The 5% difference for a local bidder, per our ordinance, was a big concern. Mr. Unrein referred to attorney. Attorney advised council should take staff recommendation on this matter, as it was his legal opinion it should be awarded to the best and lowest bid. If the local bid was not that, the city could be sued and could end up paying double for the work, as he could not defend their action. Attorney recommendation was to go with the lowest and best bid and revisit the 5% clause in the ordinance later.

This could go to a work session to be reviewed and changed.

After many comments and discussion, Bill Moritz called the question.

After hearing the attorney's comments, Paul Freese, pulled his second and Mayor asked if Doris Borgelt wanted to withdraw her motion. She stated she did not. The Mayor asked for a second or the motion would die. Cricky Lang seconded her motion (to amend and award the contract to the local bidder New Coat Sealing.) Roll call vote: Moss, no; Borgelt, yes; Lang, yes; Fitter, no; Moritz, no; Amato, no; Freese, no; Kownacki, no; 2 yeas, 6 nays. Motion failed.

City Clerk Diane Waller read ORIGINAL RESOLUTION NO. 12-23.

A motion was offered by Bill Moritz to approve and so moved. Seconded by Ken Moss.

Again, the attorney was questioned as to what can and should be done with this resolution.

Roll call vote: Moss, yes; Borgelt, no; Lang, no; Fitter, yes; Moritz, yes; Amato, no; Freese, no; Kownacki, yes; 4 yeas, 4 nays. **Mayor broke the tie by voting in favor, yes;** following the attorney's advice. 5 yeas, 4 nays. **Resolution passed.**

Attorney addressed the council's concerns again and suggested a work session to discuss this. Council members defending their vote expressed more comments.

Paul Freese felt the city encourages people to shop in Arnold so we should also hire Arnold companies. Doris Borgelt was concerned as there are often change orders so the bid dollar amount could change later.

Treasurer Kroupa stated regardless of how council felt, they should follow the rules and if our ordinances are such, they need to be followed.

A Motion to purchase a Diesel Generator

Mayor explained this could be used for many events, farmers market, summer concerts, and emergency situations when the power is out. Mayor added \$10,000 was received from Larry & Lloyd Jones for the Farmers Market. The council can waive formal bid procedures, as this money is 100% donated. Phil Amato offered a **motion to purchase the diesel generator** and so moved. Seconded by Paul Freese. Roll call vote: Moss, yes; Borgelt, yes; Lang, yes; Fitter, yes; Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; 8 yeas, **Motion carried**.

Mayor acknowledged this generator is probably worth \$25,000. He also added we have received \$1,000 donation from Dan Jones.

Dear Mr. Counts,

I am writing to you as both a Mom and a concerned citizen of Arnold. I have lived on Glatt for 12 years and I can honestly say that I love my neighbors. My husband and I have two children, ages 9 and 6.

I can tell you that since I have lived there speeding has been a constant problem. I am seriously almost out of options here. I have written Mark Powell in the past and I have contacted the police department. My letter to Mr. Powell went unrecognized. I never got a phone call or even a letter back from him. I tried contacting him personally on the phone, but each time my call was returned by someone at the Arnold Police Department.

I truly understand that the officers in Arnold have very important jobs. I also understand that sitting on our street is not always a top priority for them and they sometimes have emergencies to deal with. At what point is it going to be a priority for anyone? Are you going to wait until one of my kids or another child in the neighborhood is either struck or killed by someone speeding before you decide something needs to be done? We now have way too many families and kids living on this street for this activity to continue.

We go through this every year at this time. It seems the speeding gets worse during the spring and summer months. The neighbors and I will call the police department to complain and then we are all reassured that they will try and come out. Unfortunately, they will sit on the street during the middle of the day and the middle of the week when there is no traffic. Please know, I truly understand, that there are times that officers have more important things to do. Another thing they have done is to put one of those traveling radar signs up on the street. People coming through there, find that a lot of fun because they will simply see how high they can get that to go. Last summer, the Jefferson County drug unit was out there. They were blown away by the people speeding. They said, they were going to mention something, but again, nothing changed.

Please, I am begging you. For the safety of my children along with all of the other kids in our neighborhood, help us. I am almost out of options here and my next step will be to contact the media. Are you going to wait until a child is killed by someone speeding before you do something?
