REPORTS FROM MAYOR, COUNCIL AND COMMITTEES

Mayor Ron Counts – Welcomed the newly elected council. He is looking forward to working with everyone and moving the City forward.

Ward 1 – Nancy Crisler – Welcomed David Owens to the City council, and looks forward to working with him. Ms. Crisler also mentioned that Jeffco Express is offering free rides to seniors over 60 years old from 4/13/2015 through 4/20/2015.

Ward 4 – Gary Plunk – Congratulated the newly elected council members.

Ward 3 – Paul Freese – Congratulated David Owens and the returning council members on winning their election. Mr. Freese also advised council that the Liquor Committee met tonight. They have received a liquor license application from A-1 Liquor at 917 Jeffco Blvd. and are forwarding a recommendation of approval.

Ward 4 – Butch Cooley – Welcomed David Owens and congratulated Phil Amato and Jason Fulbright on their election wins. Mr. Cooley also thanked everyone for their support in regards to the passing of his wife.

Dan Kroupa – Thanked the Mayor for the committee appointments. Mr. Kroupa is also looking forward to the upcoming Community Summit on 4/23/2015 and encourages anyone who would like to attend to contact Mary Ellen Cox. Mr. Kroupa would also like to see the council discuss inclusion in a future budget to utilize the 4 acres that were purchased next to Ferd B. Lang Park.

Ward 2 – David Owens – Thanked everyone for their support during and after the election. He looks forward to working with everyone. Mr. Owens also thanked the staff for being so welcoming.

Ward 3 – Phil Amato – Asked Ed Blattner if he knew of any federal grant funding available through the Clean Water Commission that may be applied for the storm water issue on Carol. Mr. Amato also inquired about the possibility of funds being available for low income residents through the EDC. He has received calls regarding Frederitzi Drive and thought if they qualify, there may be funds available. Ms. Holden explained these funds are for structures, not roads. Mr. Amato also spoke regarding a couple of rescue groups that have contacted him regarding the capture, spay/neuter and release of feral cats and how expensive it is to carry out this process. Mayor Counts informed Mr. Amato that these rescue groups will be back shortly to discuss this at a work session.

Ward 1 – Jason Fulbright – Welcomed the new and returned council members. Mr. Fulbright also thanked the council for their vote of confidence in electing him Mayor Pro-Tem. He thoroughly enjoyed the work last year and is looking forward to accomplishing even more this year. He is excited to affect positive changes with the council in areas such as storm water issues, the growth of our Parks and Rec Department and the Farmers Market, to name a few.

Mr. Fulbright turned the microphone over to Mike Evans from the Veterans Commission, who spoke regarding some positive changes that have been made to the Flag initiative. With the help of the Public Works Department, they will be placing flags, with the solar lights, on conduit poles placed in the ground. They will start by placing flags at Jeffco Blvd and Highway 141 and at the Round-A-Bout near the Recreation Center. They may place the flags on poles in the future, but for now Mr. Evans is asking for council approval to begin placing flags on the ground with the new poles. There were no objections voiced by council.

Ward 2 – Brian McArthur – Congratulated Butch Cooley, Phil Amato and Jason Fulbright and welcomed David Owens.

Chief Shockey – Would like to re-hire an officer that previously worked for the City. He needs council approval as he would like to re-hire her at her previous pay grade, which is Step 4. Bryan Richison – Congratulated the newly elected council members. He also thanked Mary Ellen Cox and Jean Kienzle for their work regarding the reception held this evening for the council's newly elected officials. In regards to Windcrest subdivision, he has been in touch with Consort Homes and they are currently getting bids from contractors to have the repair work done as requested by the Public Works Department. Mr. Richison believes the work may begin as soon as this summer. Mr. Richison stated he will have a full report on Donna Drive ready for the next work session. Our storm water consultant is scheduled to speak at next months' work session and storm water issues will also be discussed at the June work session. Mr. Richison also stated he is sincerely impressed with the work our Veterans Commission has done.

Tammi Casey – Congratulated the newly elected council members. Also informed the council that on May 13, 2015, Senator Blunt's office will have a representative available in the Council Chambers to hold a question and answer session with area residents.

Mary Holden – Stated that the Subdivision Trustee Training session held last Saturday was very well attended and extremely successful. There will be another extended training session held in the future.
