BUSINESS FROM THE FLOOR

Mayor Pro-tem Randy Crisler explained how the ordinance allow guests to speak for 3 minutes on any topic but must identify themselves and state their address.

Mr. Rodgers, 861 Morningside in the Hyde Park subdivision, reported he has a neighbor disturbing his peace, harassing him, driving ATV's carelessly and was asking city's help to take care of this bad situation.

Chief Shockey explained that the city needs a written complaint to take action and Mr. Rodgers indicated he was now ready to do this.

Brian Waldrop, 3273 Telegraph, representing Operation Clean Stream, advised council the next cleanup will be Saturday, August 23, 2008 and was again asking for city's assistance and support as they have done in the past.

Butch Cooley offered a motion and so moved that **city once again support Operation Clean Stream on August 23, 2008 and provide the same manpower, equipment and support** as they have done in the past. At this time he stated he would like to move Item 14 A, a conditional use permit for a custard stand at 3891 Jeffco, to this part of the meeting. No objections were voiced and a motion to amend the agenda to move Item 14A was offered by Jerel Poor and he so moved. Seconded by Matt Hay. Roll call vote: Hay, yes; Ems, yes; Cooley, yes; Amato, yes; Deckman (excused); Moritz, yes; Poor, yes; Crisler, yes; 7 yeas, motion carried.

Mary Holden stated the Planning Commission held a public hearing and considered the request for a custard stand at 3891 Jeffco. They are recommending approval with the conditions noted. She added the applicant would like to see the hours adjusted to 11 am to 11 pm. Jerel Poor offered a motion to change the condition to reflect this change in operating hours from 10 am to 10 pm to read hours of operation are restricted to 11 am through 11 pm, seven days a week and then so moved. Seconded by Matt Hay. Roll call vote: Hay, yes; Ems, yes; Cooley, yes; Amato, yes; Deckman (excused); Moritz, yes; Poor, yes; Crisler, yes; 7 yeas, motion carried.

There were no additional comments or objections so the permit stands approved with the addition of the change in hours from 11 to ll.

A motion to approve a supplemental agreement with Crawford, Murphy and Tilly for construction, inspection and material testing services on the church road projects was discussed. Bill Moritz offered a motion and so moved to authorize the Mayor to sign **Supplemental Agreement No. 3 with Crawford, Murphy & Tilly, Inc.** in the amount of \$34,690.00. Seconded by Jerel Poor. Roll call vote: Hay, yes; Ems, yes; Cooley, yes; Amato, yes; Deckman (excused); Moritz, yes; Poor, yes; Crisler, yes; 7 yeas, motion carried.

A motion to award the bid for the **renovation of Pomme Creek Golf course, Hole #15** to Houska Inc. was discussed. Bill Moritz offered a motion and so moved to award the bid for the materials and labor to **Houska, Inc, in the amount of \$90,527**. Seconded by Jerel Poor. Roll call vote: Hay, yes; Ems, yes; Cooley, yes; Amato, yes; Deckman (excused); Moritz, yes; Poor, yes; Crisler, yes; 7 yeas, motion carried.

A motion to award the bid for **65 gallon roll out recycle carts** was discussed The lowest bid was received from an out of town company Rehrig Pacific.

Council members expressed they would like to give preference to a local business as long as product is equal or better and we still meet grant requirements. A motion was offered by Butch Cooley to award the bid to Armor Equipment here in Arnold. Seconded by Al Ems.

More discussion. Mr. Unrein would like to discuss with the grant panel to determine if they would accept this choice since it was not the lowest bid but a local bid within 5% and we would not lose the \$100,000 grant helping us with this purchase. More discussion. Mr. Cooley withdrew his motion and Mr. Ems withdrew his second. Mr. Unrein will follow-up and report back.

Bill Moritz complimented those responsible for the condition of the golf course especially where the Pomme Creek flooded and stated that area looks better than ever.
