Mayor Ron Counts called the meeting to order at 7:00 p.m.

The Pledge of Allegiance was recited.

Father Charlie Ferrara of St. David's Catholic Church offered the opening prayer.

MIRMA PRESENTATION

Jeanette Yount, who is the first City of Arnold employee to be voted into the MIRMA Board of Directors, presented Chief Shockey with a plaque from MIRMA in recognition of 100% participation in the Police Law Institute's Monthly Update.

BUSINESS FROM THE FLOOR

Doris Borgelt, 653 Louisa – Spoke regarding the upcoming fiscal year city budget. She presented a list of items she felt the city should not have spent money on while at the same time cutting the benefits of city employees.

Byron Hester, 1728 Rhythm Lane – Asked the council to explain what the "money crunch" that he hears the city is having is all about.

Lloyd "Al" Rodgers, 861 Morningside – Spoke regarding an article he read in the "Letter" section of the Leader newspaper regarding the Fox C-6 School Board. He disagreed with a portion of the letter that was written by a citizen and stated he feels that the children should always be the first priority of any school board.

Mike Bonnot, 2354 Lee and an City of Arnold employee – Stated he has lived in the City of Arnold since 1984 and is proud of what various councils have accomplished over the years. He is also proud of our Police Department and City employees. He believes the council should approve of residents paying for their trash just like they do any other utility. He also believes the City should not spend money on certain other projects while turning their backs on its employees by cutting their benefits.

Clinton Wooldridge, President of the Arnold Police Officers Association – Spoke regarding the 2015 Fiscal Year Budget. He asked why free trash and a co-working space project were being considered while it is in the budget to lay off employees and cut benefits.

Mayor Counts stated that the City is not in a crisis yet but they are trying to prevent one in the future. Different budget ideas will be brought to the council next week and nothing is cast in stone. He asked the employees to be patient and hang in there just a little bit longer stating, "there is a light at the end of the tunnel".

Mr. Blattner also informed council that the Streets Department will be receiving a delivery of salt next week, however it will be approximately 60% more expensive than last year.
