Renovation of City Hall's Landscape - Rev. 7/28/21

Paver Sidewalk & Seating Area

Includes required labor and below specified materials for the of new paver sidewalks and sitting area per plans and following specifications: Remove and haul away remaining existing pavers, concrete sidewalk, concrete pads in front of each entry doorways, and unwanted base materials. Pavers at ADA ramps to be installed per attached "City Hall ADA Spaces" document. Install below specified pavers per plan, including all the way up to entry door thresholds, and per landscape designer's onsite layout. Install 500x woven geotextile fabric, in area of paver sidewalk, as sub-base of base materials. Install and compact a 1" minus base, minimum of 4" thick. Slope sub-base on a 1% to 2% slope for proper water runoff. Install a 1" layer of Medium Meramec sand (ASTM C33) atop 1" Minus for paver bed. Install new pavers, specified below, on paver bed. Install Paver Pro rigid paver edging, with 10" galvanized nails, along exposed paver boundary edges as needed. Compact pavers for precise leveling and install Techniseal's, HP NextGel polymeric sand in paver joints. Compact paver surface and install additional polymeric sand, specified above, as needed, and water down.

Building Landscape

Includes required labor and below specified materials for the installation of new landscape per plans and following specifications: Remove and haul away all existing raised brick planter bed walls, paver sidewalk as needed to allow for new planter beds, and all related unwanted debris. Remove and haul away existing unwanted landscape vegetation, planter bed ground covers, and all related debris including tree and shrub stumps. Install new freestanding and column units, specified below in outdoor sitting area per plan and per landscape designer's onsite layout. Stone to be installed per Manufacturer's specifications. Swale basins' of dry creek bed along right side of building and cobbler accent areas for water control and aesthetics per plan and landscape designer's onsite layout, and install geotextile fabric for gravel base. Install 'cut' stockpiled

soil on low sides of dry creek beds and cobbler accent areas to create a deeper swale as needed. Install below specified boulders within and alongside edges of new dry creek beds, cobbler accent areas, and throughout mulch planter bed locations. Out cropping boulders to be set onsite by onsite foreman and landscape designer and backfill with screened topsoil. Screened topsoil to be install in mulch planter bed locations for mounding and overall bed accents per landscape designer's onsite layout. Landscape vegetation to be placed onsite by landscape designer per plan and onsite discretion, and installed with new screened topsoil. Decorative cobblers and gravel to be installed atop new geotextile fabric in base of dry creek beds and cobbler accent areas. Spade edge new mulch planter bed locations and install mulch to approximately 3" thick.

Layout of fixtures will be done by landscape designer onsite per plan. Transformer to be install on Southeast side of building, by an existing 120v outlet, or one installed By Others, at least 18" off ground. Contractor to plug transformer into 120v GFI outlet. All fixtures to be install with 12-2 low voltage wire, at minimum, with Dry Conn connectors. Low voltage wire to be buried underground at minimum of 4" and under new paver areas through conduit.

CONTRACTOR AGREEMENT

THIS AGREEMENT made by and between <u>Shelton Landscape & Maintenance INC.</u>, hereinafter called the Contractor and <u>City</u> of Arnold, hereinafter called the Owner.

WITNESSETH, that the Contractor, and the Owner for the considerations named, agree as follows:

ARTICLE 1. SCOPE OF WORK

The contractor shall furnish all the materials and perform all the work shown and/or described in the specifications entitled above, as it pertains to work performed on property address, specified above.

ARTICLE 2. THE CONTRACT PRICE

The Owner shall pay the Contractor for the material and labor to be performed under the above specified Contract price, subject to additions and deductions pursuant to change orders authorized by both the Contractor and Owner.

ARTICLE 3. PROGRESS PAYMENTS

Payments of the Contract Price shall be timely paid in the manner following: **Deposit payment of \$69,875.00 to be paid upon acceptance of proposal.** Down payment must be received within 10 days of proposal acceptance to ensure there is efficient timing for ordering of material, any required permit and associated fees, and but not limited to the delay in project start date from initial estimate. The final payment of \$69,875.00 is due after the project has been completed and approved by the Owner or the general contractor. **The final payment may not exceed 10 business days from the project's completion.**

Furthermore, Contractor maintains the absolute right to enter the property anytime, with or without notice, to remove and take possession of all unused materials, plants and all equipment owned or leased by Contractor. Contractor may also file a lien against the property pursuant to Section 429.010, et seq., of the Revised Statutes of Missouri to secure

payment of work or labor completed, machinery or equipment rented, materials, trees, plants or any type of landscaping goods or services furnished.

ARTICLE 4. GENERAL PROVISIONS

- The Contractor shall furnish a plan and scale drawing showing the shape, size dimensions, and specifications for any engineered or permit required project, a description of the work to be completed, a description of the materials and equipment to be used, and the agreed consideration for the project.
- 2. Any unforeseen expenses arising from engineering design changes by Jefferson County or otherwise, hidden sub grade complications; including any utility or irrigation lines or pipes, footings, old concrete, ledge rock and boulders will be billed at a cost of time and materials. If the home owner or contractor is not made available within 24 hours to witness and assess the situation, work will continue without a change order and documentation of the excavation and costs will be provided.
- 3. Contractor is not an engineering firm and is not licensed to practice engineering. Nothing in this Contract shall be construed as requiring Contractor to make any engineering calculations or engineering judgments. Owner may wish to consult with an engineer before signing the Contract. Where the work includes the installation of pavers, Contractor to install all paver surfaces per the Interlocking Concrete Paver Institutes (ICPI) construction standards. Where the work includes the installation of walls, Contractor to install per specific block manufacturers specifications.
- 4. Contractor shall have no obligation to perform a change in the work unless Contractor and Owner sign a change order describing the change and the corresponding adjustment in the Contract Price. All change orders shall be in writing and signed by Owner and Contractor, and shall be incorporated into, and become a part of, the Contract.
- 5. Contractor will call 1-800-DIG-RITE to mark all public utilities. Further, Contractor will make every effort to use caution to avoid unmarked underground obstructions not marked by Dig Rite, however any damage to unmarked private utilities, irrigation lines, invisible pet fences, underground electrical lines or other underground obstructions not located by Dig Rite will be the sole responsibility of the Owner, and Owner agrees to hold harmless, indemnify and defend Contractor from any liability resulting from damage to said obstructions.
- 6. Owner is responsible for disclosing all information pertinent to the construction plan and proposal, including structural elements, so to prevent negligent business. Contractor is not responsible for damage to Owner's property during demolition or removal of debris where not previously made aware by the Owner.
- 7. Contractor is not responsible for any cosmetic damage done to private or public roads, driveways, and/or sidewalks when accessing Owner's property for site enhancements. Contractor to use skid steer and mini excavator both with tracks as needed for proper removal and installation. Contractor agrees to remove all debris and leave the premises in broom clean condition.
- Contractor may at its discretion engage subcontractors to perform work hereunder, provided Contractor shall fully pay said subcontractors and in all instances, remain responsible for the proper completion of this Contract.
- Contractor warrants it is adequately insured for injury to its employees and others incurring loss or injury because of the acts of Contractor, its employees or subcontractors.
- Contractor shall charge to obtain all permits & local business licenses necessary for the work to be performed.
- Contractor shall not be liable for any delay due to circumstances beyond its control, including but not limited to weather, project changes, equipment failure, and casualty or general unavailability of materials.
- 12. Included with this Contract is Contractor's standard Limited Warranty, found at www.shelton-landscape.com, which shall commence upon final completion of work and is valid only if full payment of work has been received.
- 13. All materials ordered or delivered to project site, as outlined in the scope of work, will be subject up to a 20% restocking fee if declined by the homeowner due to changes in the scope of work.
- 14. This contract and its performance are governed by the laws of the place of the project. A lien waiver shall be furnished, if requested, to Owner upon payment of the Contract Price in full. Missouri law requires the furnishing of the following notice:

NOTICE TO OWNER

Failure of this contractor to pay those persons supplying material or services to complete this contract can result in the filing of a mechanic's lien on the property which is the subject of this contract pursuant to Chapter 429, RSMO. To avoid this result, you may ask this contractor for "lien waivers" from all persons supplying material or services for the work described in this contract. Failure to secure lien waivers may result in your paying for labor and material twice.

15. The Contract is the entire agreement and consists of these General Provisions, Scope of Work, Time of Completion, Contract Price, Progress Payments, and Shelton Landscape's Limited Warranty. There are no other agreements, oral or written, between Contractor and Owner. All previous statements, representations and promises by Contractor are null and void; there is no right to rely upon any such statement, representation or promise.
