**REVIEW AND APPROVAL OF AGENDA:** Motion by Jeff Campbell to approve the agenda as presented. Second by Del Williams. Voice Vote – *Unanimously Approved*.

7. INTRODUCTION OF NEW COMMUNITY DEVELOPMENT DIRECTOR DAVID BOOKLESS: David Bookless gave a brief background on himself. He then gave a few examples of some ideas he has such as revamping the staff reports; providing power point presentations and updating codes.

**8. OLD BUSINESS/COMMISSIONERS REPORT:** Frank Kutilek commented on snipe signs and what St. Louis County is trying to do by enforcing the rules.

David Bookless commented that we are going to be more proactive with removing the snipe signs and recently purchased roofing shovels for each of the inspectors in order to get the signs high up on telephone poles.

Ted Brandt commented that he noticed at the carwash on Tenbrook they put up a little barrier.

Christie Hull-Bettale commented that they forgot to put it there originally, but it is a 6 inch curb.

Ted Brandt also commented that when you pull into the car wash, you can see into the kitchen of the house behind it.

Christie Hull-Bettale stated that a six foot fence was approved but she will look at it.

Brian McArthur referred to the area by 2069 Missouri State Rd., where the proposed assisted living facility may go, and asked the Commissioners if they would prefer it to stay commercial or change it to residential. Consensus was they would prefer it to stay commercial.

Andrew Sutton stated for the record (with two councilman present) that he opposes any tax abatement for the assisted living facility. He believes there is a time and place for tax abatements such as the can plant. He believes tax abatement cheapens your city to some extent and feels the city should take a stand and not give in.
