Mayor Ron Counts offered the opening prayer.

Mayor Ron Counts, Chief Shockey and Captain Ruckman presented commendations to the following officers, detectives and dispatcher for their excellent work in the investigation and subsequent arrest in a recent attempted kidnapping case in the parking lot of Schnucks on Richardson Road. BUSINESS FROM THE FLOOR

Mayor explained the procedure to speak that is set by ordinance and the need to provide speaker cards.

Lemuel Hester, 1728 Rhythm Lane – Thanked the Police Department for the extra patrol given to his property while they were on extended vacation. He also wanted to commend the Police Department on their work regarding the arrest of an adult in a recent juvenile rape case in his area. Mr. Hester stated he loved the commendation ceremony tonight.

Clay Frenzel, 1955 During Circle – Wanted to inquire how sewer bill overages were figured. He purchased a humidifier in November and hasn't been able to shut it off very much due to the dry air. Since that water is not going down any drains he wanted to know if there was some sort of waiver he could obtain. Mayor informed him to go to the City Clerk's office and they could explain the processes to him.

Doris Borgelt, 653 Louisa – Spoke regarding the council's decision to refund the Ozark NID and Fawn Drive Sewer Sub. She also stated that she does not believe that the city should pay for four additional police officers to patrol the shopping areas in the city. To add officers is fine, but not to simply patrol those areas.

Lloyd Al Rodgers, 861 Morningside Lane – He thinks it is very sad that the Jaycees lost the License Bureau contract. They do a lot for the city and it is a great organization. He encourages everyone to read The Leader and see all the good the organization has done for the city.

Mary Elizabeth Coleman left the Council Chambers at 7:35.

Paul Freese stated that the Liquor Committee had met tonight. Ed Rousan is holding a Veteran's Picnic at Arnold City Park on July 12, 2014. They are using the South County VFW as their vendor for food and beer. He is requesting the city provide a letter, as it did last year, stating that we grant permission to hold this event and we require no special licensing, so that the VFW can apply for a temporary caterer's picnic license with the state. Paul Freese made a motion and so moved to supply a letter to Ed Rousan granting the city's permission to hold this event with no special licensing required from the city. Seconded by Nancy Crisler. Mayor Ron Counts – Announced his retirement from Counts Auto Body as of the first of this month.

Ward 3 – Paul Freese – Mentioned that surveyors have been at the Jeffco and Tenbrook intersection. They were hired by MoDot and Fox Schools to look at that area for possible intersection changes to make it safer for the public and students.

Ward 4 – Butch Cooley – Stated that he had received a phone call from a resident asking why all of our city vehicles don't have a city logo on them. Ed Blatter stated that they all do have the logo, some just aren't as big as the others. Mr. Cooley asked, if possible, that all vehicles have the larger logos.
