Mayor Mark Powell called the meeting to order at 7:38 pm.

The Pledge of Allegiance was recited.

Mayor Powell asked for a moment of silence in honor of the 3403 that have lost their lives in Iraq.

Bill Moritz moved to **accept the minutes of the December 18, 2008 meeting** if there are no deletions, errors, or corrections. Seconded by Butch Cooley. Roll call vote: Poor, yes; Hay, yes; Moritz, yes; Crisler, yes; Amato, yes; Cooley, yes; Deckman (excused); Ems, yes; 7 yeas, **motion carried.**

ACCEPTANCE OF THE WARRANTS:

City Clerk Diane Waller read payroll warrant #1045. Bill Moritz moved to pay payroll warrant #1045 pay period ending December 12, 2008, in the amount of \$233,473.25 if the monies are available. Seconded by Jerel Poor. Roll call vote: Hay, yes; Poor, yes; Moritz, yes; Cooley, yes; Amato, yes; Crisler, yes; Deckman (excused); Ems, yes; 7 yeas, motion carried.

City Clerk Diane Waller read payroll warrant #1046. Matt Hay moved to pay payroll warrant #1046 pay period ending December 26, 2008. in the amount of \$242,839.39. Seconded by Al Ems. Roll call vote: Hay, yes; Poor, yes; Moritz (abstention), Cooley, yes; Amato, yes; Crisler, yes; Deckman (excused); Ems, yes; 6 yeas, 1 abstention motion carried.

City Clerk Diane Waller read general warrant #5490. Al Ems moved to pay general warrant #5490 in the amount of \$846,186.89 if the monies are available.

Seconded by Jerel Poor. Roll call vote: Poor, yes, Hay, yes; Moritz, yes; Crisler, yes; Cooley, yes; Amato, yes; Deckman (excused); Ems, yes; 7 yeas, motion carried.

BUSINESS FROM THE FLOOR

Mr. John Walker, 618 Harris, voiced his opposition to the red light cameras and questioned who wrote the ordinance and asked if anyone associated with the city had received money from the company.

Paul Vinson, 2118 Richardson, stated 1000 signatures had been collected and they want to see the red light camera issue placed on the ballot for a vote.

Mr. Frank Pointer, 1009 Southgate, read a prepared statement endorsing the red light cameras. He feels they do save lives.

Mr. Joe Werner, 2481 Hickory Square Parkway, former principal of Rockport, shared his experiences witnessing violators running the light prior to the installation. He asked for data and said this was a safety issue.

Mr. Gerald Bast, 1881 North, questioned Mr. Cooley about his interaction with Mr. Hay during a council meeting. Mr. Cooley explained Mr. Hay had used Cooley's granddaughter's picture on his website and Mr. Cooley was upset by this and will do whatever he needs to in order to protect his granddaughter.

Ms. Phyllis Polson, 501 Hickory Manor, expressed her support for the red light cameras and added she feels the locations with them are not safer for her own grandchildren.

Norman Moss, 2270 Fawn Drive, admitted he was originally opposed to the cameras but is now, from a safety aspect, all for them.

Candace Throm, 80 Hickory Bluff Lane, felt the city should have tried other options before going with the cameras and thinks the photo should be of the driver with points being charged to that driver.

Jim West, 656 Madison, thanked those involved in making our intersections safe by the installation of the red light cameras. He added he felt the petitioners went to only select areas and residents were mislead into signing. Feels this is all politics.

Gary Luebbers, 1890 Edgemont, agreed with Ms. Throm's statements and feels this issue needs to be voted on by the people so they may have a say. He also said he wants an audit of the city.

Mr. Faith Welker, 2116 Doe Run, admitted she no longer shops in Arnold but feels residents need an opportunity to vote and thanked the 3 guys responsible for the petition.

Jim Edwards, 3338 Boca Raton, stated while he was on the council he voted for the red light cameras and feels they should stay as those running the lights are breaking the law.

Mr. Dennis Jackson, 1918 Maple, stated he had no problems with the red light cameras with the exception of the one located at Astra Way. He felt it was hazardous because of the speed of the vehicles approaching that intersection from Highway 141.

Lloyd Rodgers, 861 Morningside, smiling, stated he felt the red lights should be installed in every subdivision in Arnold.

Doris Borgelt, 653 Louisa, stated she had personally collected some of the signatures on the petition and people had thanked her for doing this.

Councilman Crisler thanked those involved for their efforts and made a statement to the effect if everyone was so concerned, why did they wait until now to bring this up. He felt it was political. **Crisler made a motion to table this discussion until Jun**e. Seconded by Phil Amato. Roll call vote: Poor, no; Hay, no; Moritz, yes; Crisler, yes; Amato, yes; Cooley, yes; Deckman (excused); Ems, yes; 5 yeas, 2 nays, **motion carried**.

Discussion followed with councilmen expressing their feelings pro and con. Chief Shockey elaborated on the stats he had provided regarding facts involving the accidents at the intersections with the red light cameras.
