Mayor Ron Counts called the meeting to order at 7:57 pm.

The Pledge of Allegiance was recited.

Rev. Norton from St. Mark's United Church of Christ offered the opening prayer.

Those present per roll call taken by City Clerk Diane Waller: Mayor Counts, Hohmeier, Moritz, Amato, Freese, Kownacki, Moss, Borgelt, Lang, Shockey, Waller, Holden, Lewis, Sweeney, Boone, Hull-Bettale, Kroupa, and Hall.

Phil Amato left the council chamber during this motion.

Bill Moritz made a **motion to amend the agenda and move the CUP for Rent to Own Auto Center, 1204 Jeffco, to just prior to ordinances and also remove motion D** (a motion to approve the purchase and installation of card readers at the public works facility.) Seconded by Paul Freese. Roll call vote: Hohmeier, yes; Moritz, yes; Amato (out of room); Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; 7 yeas, motion carried.

Paul Freese left the council chamber.

#### **ACCEPTANCE OF MINUTES:**

**Cricky Lang made a motion and moved to accept the minutes for the January 3, 2013 meeting if there are no additions or changes.** Seconded by Doris Borgelt. Roll call vote: Hohmeier, yes; Moritz, yes; Amato (out of room); Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; 7 yeas. **Motion carried.**

Both Mr. Amato and Mr. Freese returned to the chambers at 8:01 p.m and Mr. Freese was in the council chamber, able to vote on the warrant.

#### **ACCEPTANCE OF WARRANTS:**

City Clerk Diane Waller read Payroll Warrant #1151. Ken Moss made a **motion and moved to pay Payroll Warrant #1151 in the amount of \$275,292.29** if the monies are available. Seconded by Sandra Kownacki. Roll call vote: Hohmeier, yes; Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; 8 yeas. **Motion carried.**

City Clerk Diane Waller read General Warrant #5587 **in the amount of \$1,056,408.62.** Doris Borgelt made a **motion and moved to pay General Warrant #5587, if monies are available.** Motion was seconded by Cricky Lang. Roll call vote: Hohmeier, yes; Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; 8 yeas. **Motion carried.**

### **BUSINESS FROM THE FLOOR**

Mayor explained the procedure to speak that is set by ordinance and the need to provide speaker cards.

**Mr. Lemuel Byron Hester, 1728 Rhythm Lane** expressed his feelings on the investigation, sharing from past personal experience, the way he thought it should have been handled. He went over his 3 minutes and Ms. Borgelt asked to let him continue to speak. He continued on, adding there are two sides to every story.

**Ms. Kate Hegger, 1645 Trinity,** a resident since 1991, was here representing the residents in her subdivision and expressed concern over some Value Place unwelcomed activities. She asked that city get involved and asked what it would take to get it back under control.

**Mr. Kent Grab, 697 Pear Tree Lane,** made allegations against the city regarding payment he felt he was entitled to.

The Mayor reminded all there are two sides to every story.

**Dennis Wooldridge, 1500 Old Highway 21,** referred to the conditional use permit for the Rental Center and thought moving the bus stop and re-designing the entrance off of Jeffco would help. He also referred to the directional painting at the round-about.

**Jane Konsewicz, 1826 Windcrest,** feels traffic will cause problems if this operation is allowed. She feels drivers will be driving by, stopping in the street and looking. This is a major concern for her.

### **CONDITIONAL USE PERMIT FOR RENT TO OWN AUTO CENTER – 1204 JEFFCO**

Mr. Amato stated there are many Ward 3 residents here tonight and they want their voices heard. He then offered a **motion to deny because of safety concerns.** Paul Freese seconded the motion. Discussion followed.

Mrs. Hohmeier stated she understood but was concerned that if this is denied, something else much worse could go in there, bringing lots more traffic than this business. She felt the bus stop concerns were similar to the one at Linderhoff subdivision in the past.

Mr. Amato shared that in the past, there was a possibility of a big Casey Convenience Store going in at the Linderhoff intersection entrance she referred to. He stated residents came and spoke, asking the city to not allow it at the entrance to their subdivision voicing safety concerns. The city listened and voted it down. There is now a business there today; and it is not the big convenience store as residents voiced their opposition and concern. If we are to be the voice of our people, listen to them. The people came here tonight and spoke.

Sandra Kownacki indicated she agreed with Mrs. Hohmeier and felt because it was in Phil and Paul's ward, they are against it and they want the rest of the council to feel the same way. She felt other councilmembers shouldn't have to vote that way as they may see it differently. She expressed concern if she did not vote the way Mr. Amato and Mr. Freese wanted.

Mr. Kroupa left the council chambers at 8:30 pm.

Paul Freese reminded her that he represents the residents in his ward and they have come to him and they represent these residents. He was encouraging other council members to offer their support by voting this down.

Mr. Moss asked Mr. Sweeney to explain how the conditional use permit is needed. Mr. Sweeney reiterated Mr. Blaunt voluntarily submitted to this process.

Staff interpreted there would be sales of autos.

Mr. Kroupa returned at 8:37 PM.

Mr. Moss spoke regarding safety concerns. There have always been safety concerns and these will continue. He felt that maybe another business could go there.

Roll call vote on **motion to deny**: Hohmeier, no; Moritz, yes; Amato, yes; Freese, yes; Kownacki, no; Moss, no; Borgelt, no; Lang, no; 3 yeas, 5 nays, **motion failed**.

Doris Borgelt made a **motion to approve**. Seconded by Michelle Hohmeier. Roll call vote: Hohmeier, yes; Moritz, no; Amato, no; Freese, no; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; 5 yeas, 3 nays, **motion carried**.

Phil Amato and Paul Freese left the council chambers at 8:40 pm.

Meeting stopped for a few minutes while many in the audience left the room.

Doris Borgelt and Bill Moritz also left the council chambers about 8:40 and returned at 8:43.

Bill Moritz offered the motion and so moved. Seconded by Cricky Lang. Roll call vote: Hohmeier, yes; Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; 8 yeas, **motion carried.**

**A MOTION TO APPROVE THE PURCHASE OF A TIRE CHANGING MACHINE FOR \$6,071.82**

**A MOTION TO HOLD A CLOSED SESSION IMMEDIATELY FOLLOWING THE CITY COUNCIL MEETING FOR THE PURPOSE OF DISCUSSING LITIGATION PURSUANT TO RSMo SECTION 610.021 (1)**

Bill Moritz offered a motion and so moved. Seconded by Phil Amato.

Roll call vote: Hohmeier, yes; Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; 8 yeas. **Motion carried.**

**NEW BUSINESS**

Sandra Kownacki asked if city could review a sewer lateral program at a work session. Chief Shockey indicated this could be discussed at a future work session.

Ken Moss reported he has had calls regarding the library retaining wall that has failed and would like an update.

Chief advised that wall belongs to the library.

Mary Holden added it was repaired before and an agreement was made after those repairs. That agreement indicated city would no longer be responsible as it is now the library's responsibility. She added the drought this summer may have contributed to the failure.

Paul Freese questioned the warranty.

Mrs. Hohmeier shared she had complaints about the audio being of poor quality when listening to the council meetings on line and hoped something could be done.

Mayor responded he is aware of this and city is looking at other options but there is more cost involved.

Mrs. Hohmeier also felt city's website should be revamped, offering more highlights and links. She would like to see a meeting set up to address these issues and offered her assistance.



Mrs. Lang reported there is a safety issue with parking on Sonny Drive that needs to be looked at.

### **OLD BUSINESS**

Cricky Lang brought up the Value Place concerns and asked what the city can do to address these issues.

Chief provided background, explaining what city did in the past and Value Place is now off of probation and the police calls have dropped. He added Value Place is very receptive to working with the city and city is being proactive in their approach.

Mayor acknowledged that Value Place is aware of our concerns and will do what is necessary. They have co-operated in the past and he will make personal contacts if need be.

Discussion, comments, suggestions and questions continued and Chief reminded all that as a business, they have certain rights and the staff there is working with the city.

Mrs. Hohmeier requested that one of the streets in the new CVS project be named Kochner, after the original owner of that property. Mrs. Hohmeier also asked for an update on the smaller trash cans offered to the elderly. She was advised by Mrs. Waller that she passed the information on to the trash hauler but to her knowledge, what was offered and was available was smaller recycling containers. Mrs. Waller will follow-up again with the hauler.

Ms. Borgelt commented that last year the city could have closed down Value Place and this is still a viable option.

Bill Moritz spoke of the many drive offs at the gas stations in the city and would like to see this discussion at a work session. This is affecting the number of police calls.

Mr. Moritz also brought up the Columbia Tree Service not being paid until tonight's warrant and again expressed to council, he felt this was wrong. He also asked about the \$6800 due the Investigative Services and attorney advised him this would be discussed in closed session.

Treasurer Kroupa had a question about his i-Pad, stating the council meeting videos can't be viewed and chief confirmed that.

Mr. Amato again spoke of the round-about directional arrows painted on the ground being confusing. Chief advised he had talked with Bryson Baker regarding this and also MoDot would have to get involved as we need their permission to make any changes to their design.

Ken Moss brought up his request to have audio recordings of closed sessions. This was followed by discussion. He referred to these as public closed sessions. Some were not sure if this could be done.

Ken Moss **offered a motion to begin this evening, with an audio recording of the closed sessions.** Doris Borgelt seconded the motion.

Much discussion followed. Concerns and opinions were expressed. Chief explained how our IT person could be involved in the handling of this and this was a concern. Attorney advised it would be better to allow staff the time to look into this and do it correctly.

Mrs. Waller was questioned by Ms. Kownacki and Mr. Moss about using a tape recorder. She indicated she did not have one. Others indicated city uses a recording device for another meeting.

**This motion was changed to record both audio and video of the closed sessions.** Both Mr. Moss and Ms. Borgelt amended their original motion and second to reflect this change. Roll call vote: Hohmeier, yes; Moritz, no; Amato, no; Freese, no; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; 5 yeas, 3 nays, **motion carried.**

Doris Borgelt reported there had been a Finance Committee meeting last week.

Cricky Lang reported for the Liquor Commission as Chair Kownacki had not attended that meeting earlier this evening. Ms. Lang recommended and offered a **motion to approve the liquor license for Circle K #1676 at 2046 Key West with William Keith Hollis as Managing Officer.**

They were asking for an original package license and on Sunday and she so moved. Seconded by Michelle Hohmeier. Roll call vote: Hohmeier, yes; Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; 8 yeas, **motion carried.**

Michelle Hohmeier reported on the Aging and Disability meeting earlier. She advised, year-end reports are ready and will be distributed. She also announced the All Abilities Expo is slated for March 2 and spoke highly of a group of cheerleaders with disabilities that will be performing.

Treasurer Kroupa also reported there had been a Finance Committee meeting last week. He reported he had attended the Jefferson County Economic Development Meeting last week and shared the city of Pevely had a huge 48% increase in the cost of health coverage for their employees, stating the coverage was now cancelled. He referred to changes in various City Administrator positions in our neighboring cities. Reported the State of the County address is coming up.

Ken Moss questioned when there would be a meeting for the Police Pension Board and Chief indicated we can set that up.

#### **REPORTS FROM MAYOR & COUNCIL**

**Mayor Ron Counts** – Reported the Chief has reached out to the schools and working closely to review security. He reported the city has been approved for the Senior Housing project, Richardson Ridge Villas with Arapahoe Development.
