QUESTIONS FROM THE FLOOR: None

7a. 2015-14: CONDITIONAL USE PERMIT FOR TVI/SAVERS ATTENDED DONATION POD AND AFTER HOURS DROP-OFF BIN (TEMPORARY BUILDING) IN PARKING LOT OF SCHNUCKS, 3900 VOGEL RD.: John Tucker questioned if undesirable or hazardous materials are dropped off, would TVI/Savers take care of removing it.

Elaine Esury stated that their trucking company will take care of removals. They have not had any issues with hazardous materials.

Randy Hoselton questioned the location.

Brian McArthur referred to a lawsuit he read about concerning their transparency and asked if TVI/Savers will make it known that they are a for-profit agency.

Elaine Esury explained that they have a contract with each charity and the charity gets paid for every pound that is donated.

Motion by Jeff Campbell to approve 2015-14, Conditional Use Permit for TVI/Savers Attended Donation Pod and After Hours Drop-Off Bin in the parking lot of Schnucks, 3900 Vogel Road, with the four (4) findings and two (2) conditions:

- 1. Provide the daily hours that an attendant will be at the donation pod and drop box.
- 2. An attendant must be present during the day. Should the attendant be eliminated, the donation pod and drop box must be removed.
