7a. 2018-20: REZONING FROM R3 TO R4, LOT 9 & 10 LILAC POINT: Dan Govero, Govero Land Services, described the location of the lots to Ted Brandt.

Motion by Del Williams to approve 2018-20, Rezoning from R3 to R4, Lot 9 & 10 Lilac Point based on the four (4) findings in the staff report. Second by Brian McArthur. 8a. 2018-22: CONDITIONAL USE PERMIT, WASHINGTON U CLINIC, 148-156 RICHARDSON CROSSING: Jeanette St. Aubin, Assistant Vice Chancellor for Clinical Affairs at Washington University School of Medicine gave a brief presentation and introduced some of her team members. The proposed use is for health care services for pediatrics and the hope to open in December of 2018.

1. The proposed use can be operated in a manner that is compatible with the neighborhood as a whole.
