## **OLD BUSINESS**

Dave Venable referred to the Drive 20 campaign and was hoping to increase fines with graduated increases in the fines for repeat offenders. There is a minimum fine now and would like this fine increased for each additional offense. This should discourage repeat offenders. Discussion followed. Sweeney stated this could be discussed at a future work session.

Butch Cooley reported he had received a call from the lady who had lost her cat as a result of wild dogs entering her yard and fatally attacking her cat. He questioned if city was staggering times so as to have coverage after 5 pm.

Mayor responded he too had a call from her and she was advised to contact the Arnold Police Department, as there is staff to respond.

Mary Holden reported she has requested her staff discuss coverage and look at scheduling.
