Mayor Mark Powell called the meeting to order at 7:40 p.m. Opening prayer was a silent prayer. Those present per roll call taken by City Clerk Diane Waller: Powell, Ems, Vinson, Crisler, Edwards, Venable (excused), Amato, Deckman, Cooley, Unrein, Waller, Holden, McKenzie, Boone, Sweeney, Shockey, Blue, and Hall.

## **ACCEPTANCE OF THE MINUTES:**

Al Ems moved to accept the minutes of the March 1, 2007 meeting if there are no deletions, errors, or corrections. Seconded by Jim Edwards. Roll call vote: Ems, yes; Vinson, yes; Crisler, yes; Edwards, yes, Venable, (excused), Amato, yes; Deckman, yes; Cooley, yes; 7 yeas, motion carried.

Note: agenda indicated minutes to be approved for March 8 – Mayor acknowledged this was a work session so minutes need not be approved.

# **ACCEPTANCE OF THE WARRANTS:**

City Clerk Diane Waller read payroll warrant #998. Randy Crisler moved to pay payroll warrant #998 pay period ending February 28, 2007 in the amount of \$227,553.64 if the monies are available. Seconded by Al Ems. Roll call vote: Ems, yes; Vinson, yes; Crisler, yes, Edwards, yes; Venable, (excused); Amato, yes; Cooley, yes; Deckman, yes; 7 yeas, motion carried.

City Clerk Diane Waller read general warrant #5447. Butch Cooley moved to pay general warrant #5447 in the amount of \$ 1,198,175.98 if the monies are available. Seconded by Al Ems. Roll call vote: Cooley, yes, Deckman, yes; Ems, yes; Vinson, yes, Crisler, yes; Edwards, yes Venable, (excused); Amato, yes; 7 yeas, motion carried.

# **BUSINESS FROM THE FLOOR:**

Shirley Haus of 1966 South thanked the Mayor and council members for the concerns they expressed after the death of her cat as a result of vicious dogs attacking the cat. She stated she feels she knows the whereabouts of these dogs and is afraid a child could be hurt. She feels it is wrong that the city doesn't have better animal control.

Mr. Cooley acknowledged he has heard from Ms. Haus. Chief Shockey then requested Ms. Haus to come see him in the morning and he will personally assist her to proceed with legal action against the owners of the dogs.

Steve Stroller, 4334 Green Grove Ct came to the microphone and said he has family roots in the Arnold area and is speaking representing United Food Workers #655. He had comments regarding the tie vote of the P & Z Commission over the recent rezoning issue and made comments directed at Wal-Mart.

Mayor Powell reiterated the council's action in sending the issue back to P & Z for a recommendation. If another tie comes, the P & Z will have to provide 2 recommendations to the council.

Ms. Stuckmeyer, 1524 Fox Ridge Ct, questioned the situation with no parking signs that have been put up at the entrance to her subdivision.

Matt Unrein indicated the city became aware of a dangerous parking situation at the entrance where kids are at risk.

Chief added the signs were posted for safety reasons and stated the parking of cars at the entrance was presenting an unsafe situation at the intersection. There is no way an emergency vehicle could get through with cars parked there. At this time, officers are giving warnings to violators.

More discussion amongst council members and Mayor regarding this situation. This will be discussed more and brought for final approval at a later time. John Winerst, 2932 North Lights, questioned why the P& Z Commission did not make a recommendation.

Mayor tried to explain what had taken place and Attorney Sweeney added a recommendation is needed as is required by our ordinances.

Candace Throm, 80 Hickory Bluff, spoke about a situation in her subdivision involving wild and feral cats. She indicated they are being fed by the occupants at 549 Hickory Manor and wants the city to do something to put an end to this dangerous situation. She acknowledge the city is trying to trap them but there are not enough traps.

Renee Stines, 545 Hickory Manor, agreed these wild cats are dangerous and expressed her fear they will hurt a dog or child. She reported feces are everywhere and this too presents a dangerous health issue. She understands there are limits as to what the city can do but wants something done.

Sweeney advised we can trap 'em, can't shoot 'em.

Discussion followed and Edwards questioned what would happen to cats that are caught. Mary Holden indicated they would be placed for adoption and if not adopted, they would be euthanized.

Jack Haus, 1966 South, asked if he had the right to take action needed if a wild dog came on to his property.

Gerald Poor, 3593 Swan Circle South, shared there will be a session dealing with Sunshine Law open to the public. This is being sponsored by Mehlville School district. Also mentioned there is a possibility of a Missouri law change that could require taping of closed sessions.

Amato offered a motion to purchase additional cages/traps and transfer money from undesignated reserves. Motion seconded by Joyce Deckman. Discussion. Amato amended his motion to include purchase additional cages/traps, transfer money from undesignated reserves, not to exceed \$2000. Seconded by Joyce Deckman. Roll call vote: Ems, yes; Vinson, yes; Crisler, yes; Edwards, yes; Venable, (excused), Amato, yes; Deckman, yes, Cooley, yes; 7 yeas, Motion passed.

Amato questioned Attorney about this issue being a nuisance and wouldn't our nuisance ordinance pertain to this.

Prior to ordinances being discussed, Mayor asked to move Items A & B for discussion at this time. There were no objections voiced by council.

A conditional use permit for various construction trailers on the triangle site with the condition that all construction trailers are removed no later than the last day in November 2008. No objections voiced by council so permit stands approved.

A conditional use permit for construction trailer at 3581 Jeffco with the condition that the construction trailer be removed upon completion and before occupancy of Fortune Bank. No objections voiced by council so permit stands approved.
