# NEW BUSINESS/OLD BUSINESS

Page 4 Regular meeting May 1, 2008

Phil Amato, offered, in the form of a **motion**, that the city seek **banking RFP's** as he would like to see some new innovative ideas and just what is available in the banking market today. Randy Crisler seconded the motion. Discussion followed. Finance Director Deb Lewis shared UMB has some of these available and she could sit with UMB and see what's out there without formally going out for RFP's. More discussion and input from Treasurer Paul Freese and Mayor Powell as they both have banking backgrounds.

Mayor suggested Ms. Lewis discusses with UMB and bring ideas forward at a later time.

Mr. Amato and Mr. Crisler **rescinded their motion and second** and replaced it with a **new motion to direct staff to research banking ideas and come back to a future work session with some new ideas**. Roll call vote: Cooley, yes; Amato, yes; Deckman, yes; Moritz (excused); Poor, yes; Crisler, yes; Hay, yes; Ems, yes; 7 yeas, motion carried.

Phil Amato then directed questions and comments to staff relating to city expenses, regarding services provided, staffing etc. He stated city has been able to do all this with monies generated with sales taxes but taxes have been declining. He emphasized how the new developments will contribute and help with the financial requirements to continue to meet city's budgetary requirements.

He offered a motion to segregate by ledger for accounting purposes the sales tax money derived from the new Triangle/Crossroads developments. Also wants council consent required in order to move these monies and at budget time, a special motion will be needed to transfer these finances.

Mayor added if this dies for a lack of a second he would like to see these monies tracked.

Discussion followed asking Attorney for legal advice. Crisler added he would like to see this go to a work session. Opinions voiced. Poor questioned how it would be determined what money was lost from one business due to another similar one opening elsewhere and felt this was political. Mr. Hay agreed, there was nothing to be gained by this.

Mr. Amato justified his request and wants to see what these new developments are contributing to the city financially.

Joyce Deckman commented on the closing of some restaurants recently were not the result of the new developments but rather other reasons and seconded the motion offered by Mr. Amato.

Jerel Poor stated he had met with Mary Holden and Bill Moritz regarding **traffic calming in Theodore Ridge**. He would like this discussed at a future work session. Mary Holden added they have met with Fire Department, Police Department and Trustees and have some ideas.

Randy Crisler added **traffic calming measures are needed on Emil** and feels the city should be responsible and address since city opened gates thus creating more traffic.

Randy Crisler reported on the recent meeting with residents adjoining the **Jackson Home development** and their reps. He asked staff to bring something back in 2 weeks on this issue.

Matt Hay questioned the **progress of the website** being updated and Matt Unrein reported it is being worked on. Suggested city look at Lee's Summit website as he felt it was superb.

Matt Hay asked about televising the council meetings and would like to see this discussed at a work session. He then offered a **motion to discuss televising the council meetings at a work session** and so moved. Seconded by Jerel Poor. Roll call vote: Cooley, no; Amato, no; Deckman, no; Moritz (excused); Poor, yes; Crisler, yes; Hay, yes; Ems, no, 4 nays, 3 yeas, **motion failed.**
