## **ACCEPTANCE OF THE MINUTES:**

# City Council 5-5-11 FOR THE RECORD

Here's a little history about the Arnold Historical Society. Only Phil Amato was a part of this history.

On Sept. 20, 2007, the Arnold Historical Society held a free lunch for all of the City Council people and Department Heads to see how we had decorated the old house trailer with all historical items. That evening the City Council meeting began at 7 p.m. The Society had three living descendants of Louis and Herlanda Arnold present and they presented a picture of their grandparents, for whom the City of Arnold is named, to former Mayor Mark Powell.

The Council meeting continued. The last item at 9:20 p.m. was Randy Crisler announcing that the Arnold Historical Society will share the house trailer with the Chamber of Commerce. No one told us at noon or asked any of us for input. The Historical Society was broadsided and Sept. 20 remains a terrible day in our history. We were to share the trailer **for six months**. **Now it is four years**. Because the Society only has 825 square feet of space, most items are stored in four different locations.

In 2011 the Society will hold a number of fundraisers to help with relocation to a much larger building, hopefully, again with the Chamber of Commerce. And we hope the City will help find that building on a well traveled street.

# A Message from the President



This is my last letter to you as president of the Arnold Historical Society. At our next meeting on November 4<sup>th</sup> we will be electing new officers for 2008. It has been an honor for me to serve as your president these past 15 months. I have learned quite a bit about the area and have met many wonderful people in the process.

When I succeeded Jack Underwood as president on August 1, 2006, I knew that I had

great shoes to fill. Jack was not only one of the individuals who started this society, but he was instrumental in researching the genealogy of many local families that have been in the area for over 200 years. When my term of office began, I had several major goals in mind, mainly to develop and improve the museum aspect at our office facility, to create a logo to improve our identity, and to have a sign placed along the road in front of our office to show the community where the society is located. I am happy to say that these goals have been achieve along with spending many hours doing research and putting together many displays, to the point that every wall at our society's office is now filled with something pertaining to the history of Arnold.

Now, that dream of having a museum that we can all be proud of is in serious jeopardy. Councilman Randy Crisler of Ward 1 made a motion at the September 20th City Council meeting to take part of our facility and have the Arnold Chamber of Commerce move in with us. This motion was approved by a vote of 7-1, with three yes votes coming from council members who are members of our society. I was stunned when I heard the news of this action. Earlier that same day we had a wonderful appreciation luncheon for the city administration to thank them for their support and allowing us to use the old parks and recreation building free of charge since our inception. Many had never even been to our office to see the work that we do. Our society, along with members of the Arnold family, even gave a picture of Louis and Hirlanda Arnold (for whom the city is named) to the City Council to hang in their chambers later that evening. Mr. Crisler's motion was the very last item on the agenda that evening. Our society was literally broadsided by this action. It is common courtesy and customary to tell a tenant when something will affect them. We were not consulted nor had any input into this situation. It will be impossible to share this facility with the Chamber of Commerce simply because of security reasons. Not only is there no room, but our major concern is that we cannot guarantee the safety of items that individuals have given to us on loan for display in the museum. It saddens me that over two years of work by so many individuals dedicated to preserving the history of Arnold will literally go down the tubes over this ridiculous motion. I sincerely hope that the City Council reevaluates their motion and realizes that this situation will not work. We will keep you posted about this fiasco in future publications.

I want to take this opportunity to express my gratitude for your encouragement and help during my term of office. I greatly appreciate the support that has been given to me during this time, and I thank you very much. Best wishes to the new officers of the Arnold Historical Society. I look forward to new ideas and new leadership as we continue our pursuit to preserve our precious heritage for generations to come.
