The Pledge of Allegiance was recited.

Before business from the floor, the Mayor asked that Mayor Pro-Tem Randy Crisler and Phil Amato approach the microphone on the floor. Mayor made complimentary remarks about Phil Amato in recognition and appreciation for the commitment he has had towards the city and he was honored as the Grand Marshall in the recent Arnold Days Parade. Plaques were presented to Mr. Amato from the Fox C-6 School District, Jaycees and City of Arnold.

BUSINESS FROM THE FLOOR

Mayor explained how our ordinances allow anyone to speak for 3 minutes on any subject, provided they identify themselves.

Jim Edwards, 3338 Boca Raton, stated he hopes the Ozark Bridge project will be done next year.

Alan Bornstein, THF, provided a detailed update on the Arnold Commons developments reporting on the progress of construction and lease signings. Also talked about the activity involving the union labor situation and the inflatable "rat". Acknowledged they are preparing for the next phase and the use of bonds.

Mayor requested that if there were no objections he would like to amend the agenda to now bring forward Item 14A Conditional Use Permit as the representative is in attendance. No objections were voiced by council members.

Wal-Mart is proposing the use of storage containers for holiday merchandise as they have done in the past. This should be the last year this would be needed. No objections were voiced so the conditional use permit will stand.

Agenda also amended to bring forward the Liquor Applications at this time, as representatives were also present.

Bill Moritz, Liquor Control Committee Chairman, stated a meeting was held tonight and they were recommending approval of the applications presented. Discussion followed.

Questions and comments were asked regarding police activity at another theatre serving alcohol and our Chief responded he has not heard any adverse remarks. A councilman questioned how the serving of alcohol would be enforced. Council agreed to permit Mr. Hoffmeister of Wehrenberg to address this. Mr. Hoffmeister proceeded to say all purchasers of alcohol, regardless of age, must present valid ID, there will be one drink per person and employees participate in numerous training programs.

Mayor questioned if this is a trend to serve alcohol in movie theatres and Mr. Hoffmeister replied "yes" explaining most of the time beer and wine will be available but on special occasions, a mixed drink would be offered to coincide with the movie playing.
