BUSINESS FROM THE FLOOR

The Mayor explained how anyone could speak for up to 3 minutes on any topic, but first must identify himself or herself and state their address.

Ms. Peterman, 1169 Hickory Ridge Trail, referred to the conditional use permit for off site signage and questioned if this was a permanent or temporary situation. Asked that residents be notified in the future.

Attorney Sweeney clarified this was not permanent at this time.

Ms. Carol Biggerstaff, from Fenton, talked about a candlelight vigil honoring Mike Patton, a 2007 Fox graduate, who had been killed in the war. He was also going to be honored with a collection of items for other soldiers wish list to be sent overseas. Mr. Biggerstaff extended an invitation to the Mayor and council to attend and participate.

Matt Hay explained that if this comes up again, proper notification would be required.

Ms. Candace Throm, 80 Hickory Bluff, voiced her opposition to the billboards and felt nearby residents had insufficient information provided to them. The residents are against these billboards.
