The Pledge of Allegiance was recited.

Brad Bean offered the opening prayer.

Mayor Counts asked for a moment of silence in recognition of the passing of Leroy Long, who was appointed to and also the last surviving member of the first city council in 1972. A moment of silence was also given in recognition of Wilson "Butch" Cordell, an employee of the city.

ACCEPTANCE OF MINUTES

BUSINESS FROM THE FLOOR

Mayor explained the procedure to speak that is set by ordinance and the need to provide speaker cards.

Bill Knittig, 2016 Buck Dr. – Spoke regarding the Community Garden and what a benefit this would be to our City and how it is supported by our community that he has talked to.

Pat Buck, 2100 Watercolor Dr. – Spoke in favor of the Community Garden, she is excited to participate. Questioned why the council wants their individual names on items for personal recognition.

Doris Borgelt, 653 Louisa – Spoke of the City's storm water fee and stated it is a tax, not a fee, per Supreme Court ruling. She also spoke about the Ozark Bridge Project being initiated by residents not the City and commented on a statement made by a council person in the Leader Newspaper about the Community Garden.

BILL NO. 2569 – AN ORDINANCE AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE COUNTY OF JEFFERSON, MISSOURI FOR ANIMAL CONTROL ASSISTANCE AND ANIMAL SHELTERING FACILITY SERVICES was read twice by Deputy City Clerk Sarah Reifenberger. Roll Call Vote: Freese, yes; Hohmeier, yes; Crisler, yes; Coleman, yes; Fulbright, yes; Amato, yes; Moss, yes; Cooley, yes; 8 yeas: Ordinance passed.

RESOLUTIONS

RESOLUTION NO. 13-73 – A RESOLUTION APPOINTING WAYNE LANGBECKER TO THE VETERANS COMMISSION FOR A THREE-YEAR TERM.

Michelle Hohmeier made a motion and so moved to approve Resolution No. 13-73. Seconded by Phil Amato. Roll call vote: Freese, yes; Hohmeier, yes; Crisler, yes; Coleman, yes; Fulbright, yes; Amato, yes; Moss, yes; Cooley, yes; 8 yeas: Resolution passed.

RESOLUTION NO. 13-74 – A RESOLUTION REAPPOINTING VARIOUS INDIVIDUALS TO SERVE ON DIFFERENT BOARDS WITH DIFFERENT EXPIRING TERMS.

Ken Moss asked if this will be a yearly vote. Mayor explained that this is only bringing everyone current for the different Boards with different expiring terms. Mr. Richison explained that this is a cleanup and going forward we will alert the Mayor when a term has expired so that he can take action or not at that time.

RESOLUTION NO. 13-75 – A RESOLUTION ESTABLISHING A FINANCIAL POLICY AND GUIDELINES CONCERNING POLICE VEHICLES. THIS RESOLUTION SHALL BE KNOWN AND CITED AS THE FULBRIGHT/COLEMAN POLICE FLEET INITIATIVE.

Chief Shockey explained the resolution and why it is important. Mary Elizabeth Coleman stated that this resolution is important so that we have a standing resolution in place to make our police fleet budget more predictable. Jason Fulbright stated this was discussed at budget time last year and will be more budget conscious. Phil Amato echoed that he supported this resolution.

Jason Fulbright made a motion and so moved to approve Resolution No. 13-75. Seconded by Mary Elizabeth Coleman. Roll call vote: Freese, yes; Hohmeier, no; Crisler, yes; Coleman, yes; Fulbright, yes; Amato, yes; Moss, yes; Cooley, yes; 7 yeas; 1 nay: Resolution passed.

RESOLUTION NO. 13-76 – A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH CRAWFORD, BUNTE, AND BRAMMEIER TO PROVIDE TRAFFIC AND CIVIL ENGINEERING SERVICES FOR PRELIMINARY PLANS AND TIP GRANT APPLICATION FOR IMPROVEMENTS TO THE JEFFCO BLVD AND TENBROOK ROAD INTERSECTION.

Paul Freese made a motion and so moved to approve Resolution No. 13-76. Seconded by Nancy Crisler. Roll call vote: Freese, yes; Hohmeier, yes; Crisler, yes; Colemen, yes; Fulbright, yes; Amato, yes; Moss, yes; Cooley, yes; 8 yeas: Resolution passed.

RESOLUTION NO. 13-77 – A RESOLUTION AUTHORIZING THE PURCHASE OF NEW PICK-UP TRUCK FOR THE CITY OF ARNOLD COMMUNITY DEVELOPMENT – BUILDING DEPARTMENT.

Questions from council followed regarding how the vehicle will be used, will it replace another vehicle or be an addition to the vehicles already in use in the department. Mary Elizabeth Coleman made a motion and so moved to approve Resolution No. 13-76. **Motion failed to receive a second.**

RESOLUTION NO. 13-78 – A RESOLUTION AUTHORIZING A LEASE AGREEMENT WITH JEFFCO SUB-CONTRACTING INC. FOR A COMMUNITY GARDEN.

Discussion followed as to how the community involved, within in the immediate area of the proposed garden, felt about having the garden in their neighborhood. Jason Fulbright stated he has heard concerns from residents regarding traffic. Michelle Hohmeier informed the council that she has signed forms from residents showing their approval of the garden. Wanda Zimmerly, who lives at 2283 Piper, was allowed by the Mayor to speak regarding the fact that she was with Mrs. Hohmeier when she talked to residents and most of them are in favor of the community garden. Mayor stated that this is a good project and he believes Mrs. Hohmeier has done her due diligence and complimented her on her hard work. Butch Cooley questioned who will pay for material and costs? Michelle Hohmeier explained that costs are covered through monetary donations and material donations.

Phil Amato invited Mike Evans to speak about the success of first Veteran's Day Parade and how the community is supporting the Veteran's. Mr. Evans then gave his report on the parade.

Michelle Hohmeier wanted to thank all who voted for the Community Garden.

Dan Bish- Spoke regarding the conditional use permit that has been forwarded on from the Planning Commission with an 8-0 vote of approval for a sign to be placed at the new development in front of Walmart. No vote from council is needed.

Bryan Richison- Confirmed the meeting with MoDOT is on Monday, November 25, 2013 at Ridgewood school at 6:30 pm. Also, Mary Ellen sent an email to everyone regarding the January 2, 2014 meeting. He wanted to be sure there would be a quorum. There will be, so meeting will occur as scheduled.

Chief Shockey – He stated the crime map based internet program is up and running. He also congratulated Kim Robertson. He had nominated her for the Missouri Police Chief's media award and she won.

Susie Boone – Stated the repaying work for Arnold City Park is scheduled for tomorrow. The large Christmas tree will be going up after Thanksgiving at the round-about and the parks staff has placed the wreaths on the utility poles and they will be turned on after Thanksgiving.

Greg Hall – The Nutcracker Ballet will be at Rickman Auditorium Sunday, December 1st at 2:00 pm. All proceeds go to the Arnold Food Pantry. Gobble Gobble Run will be on Thanksgiving Day. He stated there have been 1068 entries so far. We have received entries from 17 different states.
