BUSINESS FROM THE FLOOR

Joni Markouski, 1431 New Haven – Addressed the council regarding traffic issues they are having at the corner of New Haven and Fox Pointe, she is asking for assistance. New Haven is a private street and people outside of the subdivision are parking on both sides of the street during school bus drop off and pick up times. This makes it nearly impossible for the residents who actually live on New Haven to get through, as the road is narrow. It also makes it very difficult for emergency vehicles to get through. She and other residents are asking for direction or assistance from the City.

Sheri Klein, 1401 New Haven – Also addressed the council regarding traffic issues at New Haven and Fox Pointe. She stated they have called police and also talked to the people parking on both sides of the road, but nothing has stopped the problem to date. She is also asking for guidance and assistance from the City.

Bryan Richison informed both that he would look into the situation. He stated that although it is complicated, as New Haven is a private street he would see what he could do to help to alleviate the situation.
