## **REGULAR MEETING**

The regular meeting of the Arnold Planning Commission was called to order by Chairman Brian McArthur at 7:00 p.m. The Pledge of Allegiance was recited by those in attendance.

**STAFF REPORT:** 2011-27, REQUEST TO EXTEND APPROVAL OF LONEDELL VALLEY PRD, MR. TERRY KLAMERT: Mary Holden explained that the Subdivision Code indicates preliminary plats are allowed up to five years for an approval. Even though this is a Planned Residential Development, she is inclined to use this section as a guide since the provision from the Zoning Code makes the assumption that the project is under construction.

Brian McArthur agrees we need to keep it within the five years and not set precedence.

Frank Kutilek has reservations about granting an extension since changes cannot be made.

Terry Klamert, 3514 Susan Dr., Imperial, MO, stated that at this time Banks are not loaning money on new projects. Also slow economy is a problem.

Todd Teuscher asked if a spec home would be built within the next two years. Terry stated he will not develop anything on this property until the Banks are ready to loan money.

Cricket Whaley commented that the type of housing in this development is what the Comprehensive Plan states we need more of.

Roy Wilde read a prepared statement (attached).
