7a. 2010-20: MINOR RECORD PLAT, THF, SUBDIVIDING LOT 11: Motion by Jeff Fitter to approve 2010-20, minor record plat, THF, subdividing Lot 11. Second by Jeff Campbell.

Jeff Otto explained that it is for financing purposes. They want to subdivide to exclude the vacant lots and then they will secure more conventional financing when those later improvements are done.

Second by Bryan Wucher. Roll call vote: Del Williams, no; Jeff Fitter, yes; Bryan Wucher, yes; Brian McArthur, yes; Roy Wilde, yes; Ted Brandt, yes; Frank Kutilek, yes; Jeff Campbell, yes; Cricky Lang, yes; Todd Teuscher, yes. 9 yeas, 1 nay – Approved.
