Mayor Ron Counts called the meeting to order at 7:04 pm.

The Pledge of Allegiance was recited.

Rev Mike Costello from Oasis Church did the opening prayer.

Those present per roll call taken by City Clerk Diane Waller: Mayor Counts, Moritz, Amato, Freese, Kownacki, Moss, Borgelt, Lang, Hohmeier, Chief Shockey, Waller, Holden, Lewis, Sweeney, Boone, Baker, Kroupa (excused) and Hall.

ACCEPTANCE OF MINUTES:

Sandra Kownacki advised there was a correction as she did not make a statement about the Aging and Disability meeting as she is not on that committee. Ms. Waller acknowledged that would be corrected. Ms. Hohmeier referred to discussion about Resolution No 12-50, advising the minutes referred to her saying local bid. This needs to be corrected to "lowest" bid. Ms. Waller advised that would be corrected also.

Bill Moritz made a motion and moved to accept the minutes as amended for the September 20, 2012 meeting if there are no more errors, deletions, or corrections. Seconded by Ken Moss. Roll call vote on amended minutes. Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; Hohmeier, yes; 8 yeas, **motion carried**.

ACCEPTANCE OF WARRANTS:

City Clerk Diane Waller read Payroll Warrant #1143. Cricky Lang made a motion and moved to pay Payroll Warrant #1143 in the amount of \$261,497.02 if the funds are available. Seconded by Bill Moritz. Roll call vote: Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; Hohmeier, yes; 8 yeas, Motion carried.

City Clerk Diane Waller read General Warrant #5580. Bill Moritz made a motion and moved to pay General Warrant #5580 in the amount of 969,543.54 if monies are available. Seconded by Cricky Lang. Roll call vote: Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; Hohmeier, yes, 8 yeas, Motion carried.

BUSINESS FROM THE FLOOR

Mayor explained the procedure to speak that is set by ordinance and the need to provide speaker cards.

Ms. Kay Morlan, 646 Emil, shared she has owned the property with her sister since May and the street is terrible. It needs to be widened and questioned if that could be done. She offered photos to the Chief and questioned where years ago the previous owner was offered money for an easement. She would be willing as the street needs to be widened.

Mrs. Mary Busby-Simpson, 2945 Bee Tree Lane, and owner of the commercial property occupied by the former Checkered Flag Motors at the corner of Jeffco and Church spoke. She requested another extension due to hardships and other circumstances that have prevented them from completing.

Mr. Amato asked council to allow another extension for 30 days.

Mrs. Hohmeier stated she didn't feel this was a safety issue and since they owned the property she felt city should allow, acknowledging they have made progress.

Chief added they are violating our ordinances but council can choose to allow this.

Mayor allowed a poll taken to allow another 30 days. 8 yeas.

Mr. Moritz stated he did not want to waive the ordinance.

Mr. Wally Lionberger, spoke on behalf of the Chamber of Commerce, sharing how the city contract with the Chamber allows them to provide for many things. He provided much detail on what all the Chamber is able to do.

Councilwoman Borgelt asked the Mayor if she could excuse herself from council and speak from business from the floor. Mayor questioned if she would like to speak at another time during the meeting but she insisted she wished to speak now.

Ms. Borgelt then stated, "My name is Doris Borgelt, I live at 653 Louisa Drive at our last meeting, we as a council, held a closed session that was supposed to be regarding personnel. In reality, that session was closed in an attempt to oust a fellow city councilmember. When he was not receptive to resigning, an attempt at forcing him out by drawing up articles of impeachment was discussed. This was not an appropriate closed session and violates Mo Open Meeting Laws. I am going to suggest that the public request an audit by the state auditor's office. Thank you".

Bill Moritz posed a question to city attorney Sweeney stating this was just a revelation of information that was held in a close session in an inappropriate manner. Ms. Borgelt, by stepping down away from this podium, actually took herself out from under the umbrella of city protection so she's not really doing this quite right and Mr. Moritz asked for attorney's opinion on that.

Mr. Sweeney stated he did know if he had an opinion at this point. The information that was provided was not in detail. He disagreed with the notion that it wasn't a personnel issue because he felt it was a personnel issue. There was no revelation about the particular individual employee involved. Any action taken against an elected official does need to be taken in public session, but no such action was taken.

BILL NO. 2523 – AN ORDINANCE AMENDING THE ZONING ORDINANCE, BILL NO. 285, ORDINANCE NO. 14.2 RELATING TO SECTION 18, DEFINITION OF TRANSIENT was read twice by City Clerk Diane Waller. BILL NO. 2524 – AN ORDINANCE PROVIDING FOR AN ADJUSTMENT TO THE FISCAL YEAR 2013 GENERAL BUDGET REALLOCATING FUNDS FOR FACILITY MAINTENANCE STAFFING was explained by Chief Shockey and Finance Director Deb Lewis. The bill was read twice by City Clerk Diane Waller. Roll call vote: Moritz, yes; Amato, yes; Freese, yes; Kownacki, yes; Moss, yes; Borgelt, yes; Lang, yes; Hohmeier, yes; 8 yeas, Ordinance passed.

RESOLUTIONS

RESOLUTION NO. 12-53 – A RESOLUTION APPOINTING JASON DOYLE FULBRIGHT TO THE PLANNING COMMISSION FOR A FOUR-YEAR TERM was discussed.

Mrs. Hohmeier commented that the resume indicated he was working on several state, local and city campaigns. Mrs. Hohmeier questioned the Mayor if he knew what city campaign Mr. Fulbright was working on. Mayor stated he did not know and felt this was irrelevant anyway. Mrs. Hohmeier disagreed and continued with questions as to how he found out about the opening. Mayor acknowledged Mr. Fulbright was told about it. Mayor added Mr. Fulbright has helped with other city boards, Farmer's Market etc. and Mayor felt he would be a good candidate. Ms. Borgelt stated the last time she spoke with Mr. Fulbright, he said he was the campaign Manager for Mayor Counts. Mr. Counts told her she had her wires crossed, as he is not his campaign manager. Paul Freese offered **a motion to approve and so moved.** Seconded by Bill Moritz. Roll call vote: Moritz, yes; Amato, yes; Freese, yes; Kownacki, no; Moss, no; Borgelt, no; Lang, no; Hohmeier, no; 3 yeas, 5 nays, **Resolution failed.**

RESOLUTION NO. 12-54 – A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A SCOPE OF SERVICES AGREEMENT WITH THE ARNOLD CHAMBER OF COMMERCE. RESOLUTION NO. 12-55 - A RESOLUTION EXECUTION OF A PERPETUAL UTILITY EASEMENT FROM SCI MISSOURI FUNERAL SERVICES, INC. was discussed.

OLD BUSINESS

Bill Moritz spoke about disaster preparedness and how council took the FEMA course. He also talked about what he had heard in a Municipal League presentation by the City Manager of Joplin and the destruction. He presented the Mayor a copy of the book written by the City Manager for Joplin that he found very good and found it worth sharing.

Michelle Hohmeier spoke to the audience tonight, advising people to be prepared. The city does what it can but people also need to be educated. The city can't supply everything for everybody.

Doris Borgelt added city has many mobile homes and slab homes and these folks need an area to go for shelter.

Doris Borgelt also questioned the city's ability to charge fines over \$500 as she interprets statutes differently and feels as a city, we can't do this. She referred to an ordinance city passed in 2003 where by fines can be imposed up to \$1000.

Mayor stated city does have shelter areas – one at the Rec Center and one at First Baptist Church. He added the ambulance district offers classes for emergency preparedness and maybe we need to look at this.
