#### **NEW BUSINESS**

Dan Kroupa spoke regarding the car accident at Highway 141 and Ridgewood School where a Grandmother was killed with children in the car. She was struck by a motorcycle while trying to make a left hand turn onto Highway 141 from the school. He stated a student who witnessed the accident sent an e-mail to Ed Blattner at Public Works who in turn sent it on to MoDot asking that something be done at that intersection. The Mayor stated he will have Robert Sweeney draft a resolution addressing this issue.

#### REPORTS FROM MAYOR & COUNCIL

**Mayor Ron Counts** – Thanked Susie Boone for her hard work with Arnold Days and extended the thank you to the Police Department. He also thanked Butch Cooley for his work with the car show along with Linda Brazeal. He welcomed Nancy Crisler to the council.

Ward 1 – Jason Fulbright – Thanked Ed Blattner and Bryan Richison for their work regarding the Tenbrook Road issue.

Ward 3 – Paul Freese – Welcomed Nancy Crisler to the council. He also encouraged everyone to attend the Farmers Market this Saturday.

Ward 4 – Butch Cooley – Welcomed Nancy Crisler to the council. He mentioned to the Chief he had received complaints regarding speeding on Arlene. Chief Shockey stated he would place a traffic officer there. Mary Holden mentioned that the city also has a traffic calming policy and people can call the Community Development Department with any questions.

Ward 2 – Mary Elizabeth Coleman – Said she will miss next week's work session due to a previous commitment that was made prior to her being elected. She also encouraged people to attend the next Coffee With Council meeting on 11/9/13 from 10:00 a.m. until noon at the Recreation Center. She thanked Ed Blattner and Bryan Richison for their quick response to the Bayshore problem. She also thanked Mary Ellen Cox for sending out the sewer letters to residents not on sewers and Mary Holden for her work regarding the post card survey to small business owners. She thanked Susie Boone for her work with Arnold Days and Phil Amato for his involvement with getting the Clydesdales for the parade.

Ward 3 – Phil Amato – Thanked Butch Cooley and Dan Kroupa for leading the way on the issue at Ridgewood School. He spoke about Butch Cooley and his racing history. He also acknowledged Troy Blacksher, an amateur photographer in town that was in the audience. He thanked Troy for all the work he has done for the city. Mr. Amato welcomed Nancy Crisler to the council.

Ward 1 - Nancy Crisler - Thanked the Mayor and members of the council for the welcoming wishes and she looks forward to working with everyone.

Ward 2 – Michelle Hohmeier – Spoke about speeding issues on Piper and asked the Chief to have it looked into. She had received an inquiry from a resident regarding kids on Grant Drive driving motorized vehicles without a helmet. Chief Shockey stated he would have an officer look into this.

Run for the Rescues, the Halloween dog party held each year will be on October 26, 2013 at the park. She thanked everyone for the appreciative words she has received regarding Arnold Days. However, the staff deserves all the accolades. They work very hard on these events. She thanked Phil Amato for leading the way with the Clydesdales.

Mary Holden – Welcomed Nancy Crisler and looks forward to working with her on dog pound issues. Her department has some great ideas. Community Development is keeping very busy and building permits are picking up. Not to the point they were before the recession, but they are inching back to where they were.

Ed Blattner – Welcomed Nancy Crisler and looks forward to working with her. Gershner Electric will be replacing the traffic lights at Old Lemay Ferry and Arnold Commons tomorrow. Next Thursday will be the I & I Study with Fribis. This should be the final submittal of the report.

Deborah Lewis - Welcomed Nancy Crisler.

Greg Hall – Welcomed Nancy Crisler. He mentioned that on Monday, 10/7/2013 the city will be hosting the Japanese National Association of Towns and Villages.
