PUBLIC HEARING

2014-27: MINOR RECORD PLAT, US SURVEY 2991 PT LOT 27 (EVERGREEN MHP), FOR HUMMEL PROPERTIES: Mr. Sutton read the staff report.

David Wiegers, 2045 Bender Ln., backs up to this property and would like to see it remain residential.

2014-28: CONDITIONAL USE PERMIT, USED CAR LOT AT JEFFCO AND CHURCH ROAD – POSTPONED UNTIL NOVEMBER 11, 2014.

REVIEW AND APPROVAL OF AGENDA: Motion by Del Williams to approve the agenda as presented. Second by Randy Hoselton. Voice Vote – *Unanimously Approved*.

APPROVAL OF MINUTES: Motion by Del Williams to approve the minutes from the October 14, 2014 meeting as presented. Second by Ralph Sippel. Voice Vote – *Unanimously Approved*.

QUESTIONS FROM THE FLOOR: None

7a. 2014-27: MINOR RECORD PLAT, US SURVEY 2991 PT LOT 27 (EVERGREEN MHP), FOR HUMMEL PROPERTIES: Brief presentation by Dan Govero. Dan clarified the current zoning line. He explained that the future plan would be a C-4 Development Plan including buffer strips.

Brief discussion with residents against this development as to the process explaining that his is just the first step. The next step, commercial site plan, will show the actual layout and they will get a chance to voice their concerns.

Motion by Ralph Sippel to approve 2014-27, Minor Record Plat, US Survey 2991, Lot 27 (Evergreen MHP) for Hummel Properties with the three (3) conditions:

- 1. Provide a ten foot (10') perimeter easement of the site to accommodate current and potential future electric facilities.
- 2. Before the record plat will be approved by City Council, the applicant provides the property owner's approval for the requested minor plat.
- 3. Provide a copy of paid taxes for the parcels involved.

8a. 2014-28: CONDITIONAL USE PERMIT, USED CAR LOT AT JEFFCO AND CHURCH ROAD – POSTPONED UNTIL NOVEMBER 11, 2014.
