**ADVERTISEMENT FOR BIDS**  
**JEFFCO/TENBROOK INTERSECTION PROJECT**

An endorsed "Proposal" for construction or improving the following routes and projects in the City of Arnold, will be received by the City until 10:00 o'clock A.M. (Prevailing Local Time) on Tuesday the 11th day of December, 2018 at the City of Arnold, City Clerks Department, 2101 Jeffco Boulevard, Arnold, MO 63010 and at that time will be publicly opened and read. Proposals (original and 1 copy) must be submitted in a sealed envelope marked "Jeffco/Tenbrook Intersection Project" and addressed to City Clerk, City of Arnold, 2101 Jeffco Blvd., Arnold, MO 63010.

The proposed work included: Grading, paving, drainage, traffic control and installation of a new traffic signal at the intersection of Jeffco Boulevard (MO 61/67) and Tenbrook Road – FOX School Entrance. The work shall be in accordance to these Specifications, Job Special Provisions, as well as the project plans. Where not specifically covered by the Specification of Job Special Provision, the Contractor shall adhere to the 2016 Edition of the "Missouri Standard Specifications for Highway Construction".

Special Needs: If you have special needs addressed by the Americans with Disabilities Act, please notify the City of Arnold at 636-296-2100. c/o Bryan Richison, or through Missouri Relay System, TDD 1-800-735-2966, at least (5) working days prior to the bid opening.

The wage rates applicable to this project have been predetermined as required by law and are set forth in these appendices. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations.

The City hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the ground of race, color, religion, creed, sex, age, ancestry, or national origin in considerations for an award.

The prime contractor must be on the MoDOT approved contractor listing and must have a Contractor Questionnaire and/or Contractor Prequalification Questionnaire with attachments on file with MoDOT not later than seven (7) days prior to the date and hour of the bid opening. See Secs 101-103 of the Standard Specifications, and Rule 7 CSR 10-15.900, "Prequalification's to the Bid of Certain Contractors". Questionnaire and Contract information are provided on MoDOT's website. The prime contractor on a project must perform, with its own staff, contract work amounting NOT less than 30% of the total original contract price.

Plans and specifications may be inspected or picked up at the City of Arnold, City Hall, 2101 Jeffco Boulevard, Arnold, MO 63010 on or after Monday, November 26, 2018. Complete instructions to bidders and proposal blanks may also be obtained from the City of Arnold, City Hall.

Proposals must be on forms provided and submitted in duplicate.

The right is reserved to reject any or all bids and re-advertises with MoDOT concurrence.

The Contract will be awarded to the lowest, responsive, responsible Bidder.
