Vendor Fees

The Arnold Farmers Market is from the first Saturday in May to the 3rd or 4th Saturday in October; approximately 25 weeks. One (1) 10' x 10' area (approx.) will be provided by the City of Arnold but sizes will vary. Vendors must bring their own tables and chairs. Some built-in counters may be available subject to availability.

- Seasonal: \$250 for one booth. Seasonal rent is due no later than one week prior to the first market date. All dates printed below are included in the Seasonal Market Rate.
- Monthly: \$50 for one booth. Monthly rent is due no later than one week prior to the first day of the month to be rented.
- Weekly: \$15 for one booth. Weekly rent is due no later than Saturday prior to the week to be rented.

There will be no charge for moderate use of electricity for vendors.
 Special Christmas Market will be \$35. Seasonal Vendors are Free.

*Please note that failure to attend the Market after reservation is made does not mean you will be refunded or credited for the day you do not appear. All reservations will be confirmed by receipt of payment. Please contact Market prior to the date that may need to be changed. No refunds are given but credit may be issued at the discretion of the Market Manager.
