**Vendor Fees**

The Arnold Farmers Market Seasonal session will be held from the last Saturday in April thru the 2nd Saturday in November. One (1) 10' x 10' area (approx.) will be provided by the City of Arnold Farmers Market but sizes will vary. Vendors must bring their own tables and chairs. No tents or overhangs of any other design may be used. Some built-in counters may be available based on availability. Fees are listed below and times are 8 am-Noon for regular markets:

- Seasonal: \$275 for one booth. Seasonal rent is due no later than one week prior to the first market date.
- Monthly: \$60 for one booth. Monthly rent is due no later than one week prior to the first day of the month to be rented.
- Weekly: \$20 for one booth. Weekly rent is due no later than Saturday prior to the week to be rented.

There will be no charge for moderate use of electricity for vendors. However, all vendors must specify their electrical needs prior to rental date. Not all electrical needs may be available. In this case, renters may need to provide their own quiet noise generator for use. \*Please note that failure to attend the Market after reservation is made, will not result in a refund or credit for the day you do not attend. All reservations will be confirmed by receipt of payment. Please contact Market a minimum of 14 days prior to the date that may need to be changed. No refunds are given but credit may be issued at the discretion of the Market Manager.

Special Christmas Market on December 14th 10 am-3 pm will be \$50. This is in addition to Seasonal Fees.

Winter Markets will be held in January, February, and March, and will not be included in the Seasonal Fee for 2025. The fee for a winter market will be \$20 per week and will run 9-11:30 am.
